


# 3 KEY CONCEPT DESIGN ELEMENTS:

# 1. DENMARK HERITAGE ART PARK & PERFORMANCE SPACE:

The central location of the site - within Denmark CBD & at junction of Strickland St Heritage Precinct & Mitchell St Heritage Precinct - offers great opportunity to create a vibrant community space.

This space could highlight the many talents Denmark has to offer and additionally provide a link to the past.

The level change invites the layout of an amphitheatre that creates areas for resting, reading, lunch, meeting, street performances and much more.

Early ideas include a circular plant layout to showcase the six local Aboriginal seasons with incorporated artwork in the seating and paving. Possibly a way finding compass could be included into the paving to help orientate visitors. Both heritage precincts could have common ground here as a meeting place to start and end heritage walks.

A strong link to the Infant Health Centre would be incorporated as this proposal requires this building to be removed. The historical and local importance of the building could be reflected in many ways. Artefacts such as measuring sticks could be part of the amphitheatre as well as reusing the bricks of Denmark's first government brick building. This could be explained with interpretive signage.

Beyond the amphitheatre the Heritage Art Park would continue into more quiet and elevated BBQ facilities protected by shade sails. This area could also incorporate heritage play equipment as well as sculptural art play equipment. The key idea is to create a low key family environment with respect to adjoining neighbours.

Another area where the theme of history and art can be continued is the proposed modular covered walkway. This walkway provides weather protection on the western side of Strickland St and is a reference to the already active walkway on the eastern side. This walkway could become a linking spine that bridges the gap from the Pharmacy canopy to the Doctor's surgery. Being modular and small in scale this walkway could be provided in places suitable and follow the contours of Strickland St and create its own broken up landscape of angled roofs.

#### **RE-INSTATEMENT OF HERITAGE BUILDINGS:**

The Denmark RSL Hall and the Denmark Cottage Craft (including Carmarthen School) form an integral part of the built and social fabric of the town.

To be easily recognised as heritage buildings the concept plan proposes to bring back these two buildings as close as possible to their original design. Later additions would be removed and the facades of both buildings restored. The necessary administration, amenities and storage facilities could be added as contemporary smaller additions that are placed in the background with sympathetic designs in relation to the original buildings.

Both buildings are proposed to open up into the new community space with a verandah (as shown in earlier photos of the Carmarthen school) and with a generous deck (RSL). In particular the deck on the northern side of the RSL hall would offer a sunny place to sit and enjoy the connection to the other facilities and the town beyond. In addition the large northern glazing would enhance the RSL hall not only thermally, but also in its usage. This would enable this building to become an even greater community asset.

#### **CBD CAR PARKING/ ACCESS:**

This Concept Plan provides for much needed CBD car parking and at the same time acknowledges the problems that come with sealed parking bays. The majority of the 21 proposed car bays are located behind the re-instated Carmarthen School building and offer 14 car bays including one disabled car bay. This part of the car parking is proposed to be made out of trafficable grass pavers. Apart from providing a natural surface these grass pavers allow storm water to disperse and provide a cooler surface in summer. Added shade trees would enhance this space further and make it feel as being part of the Heritage Art Park.

There are 3 further car bays proposed for a more formal parking near the RSL back entrance (including one disabled). And finally some additional 4 car bays could be provided along Bent St. This arrangement is shown pending a Bent St review.

With regards to disabled access; the accessibility was a priority consideration for this concept. Two ramps were included to allow for direct access from Strickland St and from Mitchell St. The paths throughout are considered to lead from different areas with appropriate fall to allow for easy access to any part of the precinct.

1	Margaret Williams 6D Willow Creek Drive Denmark	I have seen the plans posted in front of the site in Strickland Street and wish to comment on a couple of features.  There seems to be no good reason for a BBQ and Play area when the excellent facilities in Berridge Park are 'just down the road', and who wants to see a boozy BBQ party in the middle of town? It is just out of character. They are also too close to Mrs Malcolm's place and could be a magnet for anti-social behaviour on the heritage buildings.
		The artist's impression also suggests the extension to the RSL Hall is ugly and again out of character to the heritage buildings.  A nice garden and benches would be far more attractive to visitors and locals, where they could enjoy a rest and a little peace in the middle of a busy CBD.
2	Jean Phillips Lionsville Gardens 7/35 Mount Shadforth Road Denmark	Also out of character are the plain covered walkways, which I think are also unnecessary.  I am not against change – for the right reasons – to remove unsightly areas and improve access to facilities, or to provide an urgently needed resource.  But to deliberately destroy the unique atmosphere and Heritage Buildings – to modernize – to become like a tourist resort. To destroy a building built by the women of this area, for their own and their children's needs and to even think of those bricks as pavers – to be trampled underfoot by all and sundry raises my ire to the maximum!  This is a total insult to these women – the mothers and grandmothers of the present generations – who, I might add are not recognized elsewhere in this town!  This Infant Health Building – the FIRST brick building in Denmark – should be kept and cared for as a memorial to them and all the babies they lost before its inceptions and those saved afterwards.  Additional Submission Correspondence:  Enclosed (Officer Comment - see end of table for plan) alternative plan to open the area for public use, keeping our heritage and
		using a local theme i.e. rocks and logs. It also retains the path and extends it to Bent St for use by gophers.  If this is too steep a ramp, path parallel to the RSL Hall up from Bent St could be added.  A centre rail could be placed up the steps.  A monument to Women Pioneers placed in the Infant Health Centre area marked 'Garden' would be an appropriate and appreciated gesture.  P.S. the Infant Health Centre would be ideal for a pictorial display of Denmark's History and Unique Beauty, that is after maintenance and cleanup has been done.  Additional Submission #2 Correspondence:  I would like to place a suggestion that on vacation by the Denmark Arts Council, that the brick Infant Health Centre Heritage

		Building in Strickland Street, be offered for use to the Historical Society for storage of all the "Historical Records of Denmark" at present packed into a jail cell in an old wooden building with little access, and for a display and work area – much more suitable than the present crammed area used to display the history of Denmark in a dingy setting.
3	Betty & Gordon Harris PO Box 771 Denmark	As a member of the Shire's Working Group on this project, I was strongly against the demolition of a significant heritage building, the Infant Health Centre, although no other Member was interested. Now I understand the Denmark Historical Society Inc have recently launched a petition to save it. Consequently, I must support the retention of the IHC and request a review of the whole project. Failing this, I submit below my comments on the Plan as advertised.
		Whilst appreciating the overall concept for the Precinct, there are a few pertinent comments on the Plan worthy of further consideration:
		1. We most strongly oppose the proposal for a BBQ and Playground area, which will undoubtedly attract, and encourage anti- social behaviour, vandalism and noise from drinking parties. Litter and broken glass would become a menace. Damages to the Heritage buildings are more likely with uncontrolled parties and games. The various groups using the RSL Memorial Hall could create problems in the Precinct and neighbourhood.
		The BBQ and Playground areas at Berridge Park are but minutes down Walker Street and cater handsomely for such activities, and include toilets on site. They are also more open and controllable. We are particularly concerned for Mrs Malcolm whose property (Lot 42) is very close to the suggested BBQ and Play area. Other local residents would also be affected. We don't think you, we or anyone else would want that sort of arrangement on their doorstep.
		Could we therefore suggest a garden area with, say, some big granite rocks, Grass Trees and plants/shrubs representing the Flora of our local area? A few benches for visitors to relax would be far more acceptable to them and neighbouring residents alike.
		2. We also feel the covered walkways are unnecessary and too modern which could detract from the Precinct's appearance from both sides of Strickland Street. Even if the idea is to eventually cover the whole length of this side, it would still clash with existing and heritage-style verandas on both sides of Strickland Street. The proposed canopies are not a good look.
		Furthermore, the footpath on the east side of Strickland is considerable lower than the west side, which would detract from, and spoil the view of part of the Precinct to people on the opposite side, with the canopies of the proposed walkways blocking a clear view of what could be, otherwise, an extremely attractive-looking amphitheatre-cum-garden setting.
		3. The addition of the rear of the RSL Memorial looks gross and completely out of character with the heritage buildings on the block and the overall concept, and should be re-designed accordingly, retaining the original-style north-facing extension.
		We believe these suggestions would make the proposed site more attractive to visitors and locals alike.
4	Dianne Francis PO Box 685 Denmark	In complimenting the Shire on the proposed Plan, there are a couple of comments I believe should be seriously considered in your final deliberations.
		I, together with others I have discussed this project with, would like to see the BBQ and Playground area deleted and changed to a garden area with a few benches for visitors to relax and reflect in peaceful surroundings, rather than what could become a noisy and boozy environment. There are far too many of those around these days – reported in the Press and T/V all the time. It could also be a fire hazard in the wrong/careless hands in what is comparatively a confined space, so close to Mrs Malcolm's (Lot 42) buildings.

		A BBQ and Playground in town is totally superfluous when more than adequate facilities are but a minute or two away in Berridge Park. It could also lead to unruly and drunken elements disturbing and damaging local residents' properties and the heritage buildings on, and close to, the Precinct in question.
		Also considered unnecessary are the covered walkways which would clash dramatically with the traditional style of verandas on both sides of Strickland Street. I also think the proposed glazing/decking to the RSL Hall completely out of character with the heritage of the building and unnecessary.
		In conclusion, could the lower part of the Plane tree be lightly pruned to permit a clear view of the heritage school/craft?
		I hope these comments help to improve what is a good concept.
5	CBD Development Working Group C/- Shire of	With regards to the draft Plane Tree Precinct Development Concept Plan (PTPDCP), the CBD Development Working Group considered the draft plan at the 18 March 2014 meeting wherein the following comments were agreed upon:
	Denmark	Remove the bbq from the plan due to the potential impacts on the adjoining residential property and noting that there are plenty of bbq opportunities in Berridge Park, Norm Thornton Park & Kwoorabup Community Park.
		Support the concept of a playground subject to it being sculptural/artistic/heritage playground and not a slide/swing type playground.
		• Consideration should be given to using native vegetation plant species in this landscape arena rather than the current CBD plantings – noting that the opportunity of re-planting some of the existing native vegetation that is currently located in front of the former Infant Health Clinic Building within the site should be explored.
		• Landscaping areas should be considered in the vicinity of the adjoining residence (to assist with noise & visual impacts) and along the Mitchell Street elevation (noting this would be low level vegetation).
		Caution should be expressed with the reference to 'amphitheatre' as it may not be the most acoustically designed space due to adjoining road noise conflicts.

7	Denmark Historical	Thank you for giving the Denmark Historical Society an opportunity, as an acknowledged stakeholder, to comment on the draft
	Society PO Box 54	Plane Tree Precinct Development concept plan. We have considered the plan carefully and make the following comments.
	Denmark	We are disappointed with the overall plan, finding it basically flawed for it fails to acknowledge the clear historical nature of the area. Instead, it has replaced what could be a historically accurate depiction of the time past with an urban-style playground that
		fails to depict the very rural/regional quality that underpins our townscape. Surely there is an opportunity here to highlight the

heritage elements from which our town has developed. There have been several requests over time to make this Precinct a true heritage-based site. Now is the time to properly explore how that can be done through wide consultation. We wonder at the proposal to create a large car parking area off Mitchell Street. Surely, if the heritage value of the whole site is being properly considered, that space could be used more appropriately. If this proposal is to go ahead then consideration must be given to addressing the narrow limit of Mitchell Street itself as it currently operates. Cars park on either side of the street turning the driving space into a single lane leading which is potentially dangerous. The increase of flow in and out of the proposed car park will only add to the already chaotic situation. The Precinct must be considered within the townsite as a whole and Bent Street also is a very narrow two-way street that will see an increase in traffic through the proposal. Most of the attributes can be achieved without 1. The demolition of the Infant Health Centre 2. Removal of part of the cottage crafts building 3. Relocating the remaining part of the building 4. With the loss of only two parking bays The grassed area available 'performance area' is not diminished. All or part of the ratepayer funds saved could go towards the rejuvenation of the Infant Health building along with some outside funding obtained by the Shire. The Society wishes to raise the rather casual dismissal of the Heritage value of the former Health Clinic without proper consultation. This does set an unhealthy precedent for future planning by the Council. This building took the community 23 years to achieve by the time it opened its doors in 1956. While not a particularly attractive building it played a major part in Denmark's history with particular reference to women and children. This section of the community often goes un recognised. The performance area that will replace it raises a number of questions about its suitability. It reflects the urban style playground that is not in keeping with the townsite, particularly with the main street itself. Are we moving to have Denmark look like a Perth suburb when we should be striving to keep the distinctive look and quality of the regional town it has been? If the site is to contain a performance space consideration must be given to deal with the amount of rain Denmark enjoys. With input from residents a better lay-out could be developed including some form of cover to provide maximum use of the space, if indeed that is the plan. The Cottage Craft building plan with its Heritage awning seems a good move though as this building attracts many senior people a ramp, as well as steps, are needed for easier access. We do not approve of the proposed admin addition. Is this addition really necessary? This building, the Old Carmarthen School was also relocated by the community and at their expense. This began initially as a hall for the town and later the Craft Group was established. This has been a huge success for the community. The covered walkway seems to be an after thought and has no real relevance to the site itself or is Council about to place covered walks along that side of Strickland Street, and if so will the Council use a style sympathetic to the veranda style still to be seen occasionally on the other side of the street? The current proposal is not in keeping with the streetscape of Strickland Street. 8 John Schindler Below are some of my comments and suggestions for the Plane Tree Precinct. If possible I would like to see other comments and suggestions which you receive. Comments 1. Car Bays – I think that it would be a shame to turn more of the town centre into a carpark. Annie Harrison Park is only 200

metres from the post office. Anyone parking at one of the main shopping centres in Perth or even Albany would walk further

		than this to get to their shop. At the North end of Strickland Street there are already 30 new parking bays and another 38 will soon be completed.
		2. BBQ – Australia already has the reputation as having the fattest population on earth. There are plenty of BBQs in Berridge Park, Norm Thornton Park and Kwoorabup Community Park. These all cost the shire money to maintain and I think there are more than sufficient of them.
		Heritage Sculptural Playground – I do not think this is really necessary as there is already extensive playgrounds in Berridge Park and the Kwoorabup Community Park.
		Denmark Heritage Art Park and Performance Space – This is another large area of bricks and seating with no shade and is not very inviting in winter or summer.
		5. Is it really necessary to locate a WW2 gun on the main street of town, why not locate it near the war memorial?
		Suggestions and Comments
		<ol> <li>Plant Native and bird friendly trees and shrubs in all the open spaces, and erect seats under the trees so that people can sit and enjoy an area free of vehicles and with some native birdlife. Children and adults I am sure would enjoy an area different from the other parks.</li> </ol>
		2. Denmark already has fewer street trees than most of the wheat belt towns and I am sure that people would enjoy some shade near the town centre before having to walk home on our shade free paths.
		3. I note that some wheel chair access is provided and this will allow disabled people to enjoy the shade and birds.
9	FM & OB Jones 13 Russell Rise Denmark	We are not against change in the town but in the last 5 years since we shifted to Denmark the feeling in the town has changed from a unique country one to the same as many other towns in the state. Firstly it was the narrowing of Strickland Street making it difficult for bigger vehicles to be in the town centre and now you wish to change the Plane Tree Precinct giving it a look of an inner city park. You appear to be catering to the tourist and not the locals who live here permanently and who pay the rates.
		The modular covered walkways look incongruous in the main street which is almost entirely heritage style. The design presented would be ineffective as a rain shelter.
		We are pleased to see the retention of the plane tree because of its heritage value and we hope expert advice has been taken so that alterations around the tree will not adversely damage the tree in future years.
		The removal of the former Infant Health Clinic Building would be an insult to many in the town, given it was the first community brick building in Denmark and has historical value and to use the bricks as pavers would be a huge insult to the women who raised the money and built this building. Do we really need an amphitheatre in the main street of town as there is a perfectly good grassed area by the river that is used for events?
		Many tourists and locals use the Denmark Cottage Crafts Building and to force this community building to shift elsewhere in town would most probably deprive this group of their customers.
		There must be better ways the Shire can utilise this section of town to the advantage of townsfolk and tourists alike.
10	Sonia Anderson PO Box 838	Thank you for the opportunity to comment on the Plane Tree Precinct Development Concept Plan.
	Denmark	I have visited the site, and considered carefully the ideas and plans provided by Pixeltrix, and the project brief and other information contained in the Shire minutes of 7 May 2013.
		My comments are informed by the architectural design principles expressed in Alexander et al. 1977, A Pattern Language. I have referenced that work because it sets out design principles that allow people-friendly spaces to be created, which I believe to be a

vital motivation in redeveloping a site in the central business district of Denmark.

#### **Summary**

There will come a time when the centre of town will need either further commercial development, a recreation-based parkland, a meeting place, a cultural centre or similar. I submit that at this time, such developments are premature. As the town grows, the relative priorities of the potential uses for the site will become clearer, and a more appropriate plan can be developed at that time.

The architects have clearly taken account of the current, pressing need for parking in the CBD, and have designed an associated development that fits with the existing topography. Unfortunately, the space has not been designed with a good understanding of human behaviour and it is likely that, despite the best intentions of the architects, people will not be drawn to the area.

I note the historical significance of the Infant Health Centre (IHC) building and the need for more parking in the CBD.

I therefore suggest the following amendments to the concept plan:

- 1. Retain the IHC, ensuring sufficient maintenance to prevent deterioration of the building.
- 2. Proceed only with those parts of the plan for which there is a clearly established need, primarily additional parking and better access to the RSL Hall.
- 3. Delay further redevelopment of the site until town growth necessitates further commercial development in the town centre and/or development of a recreational facility or cultural centre in that locality.
- 4. Develop, in consultation with the community, a master plan for staged redevelopment of the section of Strickland Street along the full length of the "void" from the Pharmacy to the Doctor's Surgery.

#### Need for the Redevelopment

The only driver for the redevelopment that has been explicitly articulated in the documents I have viewed is the need for additional parking in the CBD.

Both the concept plan and the council minutes identify the "commercial void" on the western side of Strickland Street, but the concept plan fails to address this issue effectively.

It is fraught with danger to undertake a development that is not needed, as it is difficult to target it appropriately. The Plane Tree Precinct Concept Plan suffers from this lack of direction.

I therefore submit that the redevelopment should be limited only to those things for which there is a clearly established need at this time and changes that will not impact on potential alternative uses for the site. These are notable:

- 1. creating extra parking bays at the western end of Lot 41 (the green parking lot idea is LOVELY);
- 2. creating parking bays on Bent Street;
- 3. changing the RSL hall entry, including installing wheelchair access from Bent Street; and
- 4. relocating the canon and the lone pine to facilitate disable access to the hall and put the pine tree in a better spot.

# **Design Principles and Critique**

The Pattern Language offers a wealth of ideas and principles to guide a development of this nature, and these are expressed in some detail in Attachment 1 (Officer Comment - see end of table for attachment document).

As most relevant here, the patterns propose that people are most likely to gather at a convergence of well-used paths. If this convergence is a public square or similar, then some built form and reasons to gather are needed at the edges of the space, around which human activity can grow.

Unfortunately the current concept will most probably fail in the following ways:

- 1. The well-used paths in Denmark are on the eastern side of Strickland Street and in the small arcades where there is commercial activity. This development does not fill the void that has been identified on the western side of the street. It simply changes the appearance of the void. The covered walkway won't make people suddenly want to walk on the western side of the street!
- 2. The amphitheatre is too large for a small number of people to sit and eat without feeling exposed. Also, the "view" is of a street intersection; not an attractive vista that will draw people in.
- 3. Unfortunately the amphitheatre will also fail as a performance space: there is no place for a band to set up and play; and buskers won't tend to play here as they would either have to face away from the seating or have the discomfort of having their backs to the street, and they will be away from the natural movement of people on the eastern side of the street.
- 4. The BBQ area and playground seeks to create activity in the centre of the place, but this is not what people prefer to do. In fact activity tends to grow from the edges. Also, the proposed BBQ area is disconnected from the vista of the street.
- 5. The total area of open space is too large to allow a comfortable density of people to develop. It is therefore likely to seem deserted and to remain unattractive.
- 6. The buildings do not create a sufficient sense of enclosure for the square: the space is more a left-over space than a positive outdoor space. A far more positive space is created if the historically-significant IHC is retained.

The patterns suggest that the current concept will succeed in the following ways:

1. The proposed small, green parking lots are of a size that is sympathetic to encouraging and supporting pedestrians in the CBD, and their greenness will make them appealing places.

#### Alternative Ideas

I submit that any development of Shire land on the western side of Strickland Street should be done as a phase of an overall plan to enliven that part of town as the population grows. I submit that such a development is more likely to take the form of buildings with associated outdoor seating and space, than a more expansive public open space. Accordingly, the existing, historicallysignificant IHC has potential as part of such a redevelopment, and should be retained at this time.

Redevelopment options should incorporate pattern language patterns in order to create human spaces, but may include the following:

- Close off the bottom of Mitchell Street and redevelop the existing library, civic centre and IHC buildings into a cultural and entertainment complex (e.g. IHC as museum);
- Develop a public outdoor room and bandstand to the north of the RSL Hall and convert the IHC to a café and bar, to create a social space and a reason to be there, and incorporate an outdoor dance floor that doubles as a chess board.

#### Conclusion

It would be a shame to spend shire funds on a redevelopment that will not be used much more than the existing grassed area. Instead, those funds could be applied to basic maintenance for the IHC building, so that it is still available for inclusion in a redevelopment at some future time, when the needs of the town necessitate growth on this site.

The concept plan looks great, however in my eyes all's not guite right about it.

The Clinic building is special to me as I took my kids there over 50 years ago. It can well be used for something else and is easily

		accessible to whatever used for.
		Fay Malcolm lives adjoining in a well-kept heritage listed home. A good high easy to the eyes fence is important for her on boundary lines.
		Let's get practical and sensible over this issue.
		So I say:-  1. Pull down the existing craft shop and they will go into the refurbished now church/ex school room.  2. Parking lots on corner of Price and Mitchell Street (not too many though)  3. The native shrubs are lovely on Mitchell Street, I frequently see people taking photos of the flowers and birds in them. It just needs a tidy up and kikuyu got out.  4. Leave the Clinic where it is. What a lovely kids library it would make adjoining the area with garden and space around it for older kids to play while smaller ones in the library or vice versa. It would give more space in the main library. It could be used for a consulting room for some health person if not a kids library.  5. Clean up the open area next to the RSL Hall, put some tables and seats under small shelter or not under shelters.  The shelters aren't needed on Strickland Street foot path. 		This town centre park should provide easy and attractive accessibility with trees providing shaded and sheltered benches/tables 'without BBQ opportunity??' (this is provided nearby). 15	Fay Malcolm 11 Price Street DENMARK WA 6333	The Development of this plan will have a great impact on me personally as I am the only resident with the development almost surrounding my property. I accept the need for parking and feel it will not alter my amenity much with a few more cars but the 4 bays in Bent Street, one of which will block vehicle access to my back garden and wood shed. The play/BBQ area and the amphitheatre will make the greatest change as both of these activities are very different to the normal traffic and business activities of the CBD and will not make for a pleasant home environment.
		The Infant Health Clinic is listed on the Denmark Municipal Heritage Inventory and included in the Strickland Street Precinct and the Mitchell Street Precinct. Only by careful reading does one discover the open space is created by the removal of the Infant Health Clinic building which has been allowed to fall into disrepair with lack of maintenance. This building provided space for the Clinic and a Doctor's surgery, both uses helping to sustain and improve the health of the community, a role of very considerable importance. I believe the removal of this building shows a very unbalanced view of its significance in relation to the RSL and the Craft Shop both of which will remain and be refurbished.
		Messrs. N. Bayley, W. Gillingham and W.E. Bayley worked for 23 years on a committee to have the IHC built. Surely the building could be left to stand tall as a monument in recognition these women and women in our community who were and are never recognised for their work in the development of our nation. They didn't go overseas and fight wars but fought a battle here to achieve a better standard of living for Australians. The removal of the building and using the bricks for seating and paving becomes a memorial to women and children to be sat and walked on! A refurbished IHC could be used for small meeting rooms, displays from groups in the community and the lockable verandah used for more robust displays when the building is not manned.
		Removal of the Craft Shop for parking has long been debated. To provide another play/family activity area negates the gain of the additional parking required for the CBD. Simple landscaping without the play area (which would be anything but quiet) with trees and benches would provide a quiet pleasant area for people using the CBD to relax and enjoy a coffee or lunch. Our children have a play area with BBQs and toilets 200m away. The PTPP area has its closest toilets 100m away, a long way for young children!

	Highway DENMARK WA 6333	At its Ordinary Meeting held on 27 April 2011, Council resolved, in part, Authorise the CEO to enter into discussions with Denmark Cottage Crafts Inc, Denmark Arts Inc. and the Denmark RSL Inc. regarding the concept of a community Art Park which incorporates Reserves 26026 & 23631 and better integrates with the streetscape.
		Subsequently, an architect was appointed. The Architect's Project Brief developed by Shire staff had critical errors or omissions which effectively misdirected the architects. Two of these were:  1. The architect was to liaise with listed key stakeholders but which did not include the Denmark Historical Society, a priority stakeholder;
		2. "Denmark Arts will be vacating the former Infant Health Clinic building by December 2013 and this building can be demolished

if desired."

3. "The Denmark Cottage Crafts building on-site can be relocated on the site".

The Draft Plane Tree Precinct Development Concept Plan was presented to Council for endorsement to advertise at its 7 May 2013 meeting. The Council resolved in part:

"Subject to it being advertised simultaneously with the Civic Centre Redevelopment Concept Plan, supported by a newly commissioned 3D perspective showing the two concept plans with their integration on the western frontage of Strickland Street between Bent Street and the Denmark Co-Operative building."

In March 2014 the draft Plane Tree Precinct Development Concept Plan was advertised on its own for comment.

So what has ended up being presented to the community is a plan directed by staff preferences. The authorisation given to the CEO at Council's 27 April 2011 meeting has effectively morphed into a virtual instruction to:

- Plan for the demolition of the Infant Health Clinic;
- Do not liaise with the Denmark Historical Society;
- Relocate the Cottage Crafts building.

In addition, as there is no Civic Centre Redevelopment Concept Plan and no 3D perspective, we now have a plan that has not been advertised in accordance with Council's 7 May 2013 Resolution.

The architects were given a lot of rope to play with and they have obliged with an impressive display of macramé. Much of the road they travelled down would not have occurred if the Denmark Historical Society had been consulted at concept development stage.

The continued love affair by some of red brick paving up hill and down dale in the CBD is exacerbating an already rising costly maintenance problem. They get dirty quickly and show it. No amount of steam clearing and other treatments of the existing Strickland Street red bricks has either sufficiently cleaned them or controlled the weed growth between each brick. To add further to these red brick surfaces just confirms a desire to mimic Perth precincts such as Rokeby Road Subiaco.

#### Recommendations

- 1. An 'art park' as originally envisaged by council remain an objective for the two reserves;
- 2. All buildings on the two reserves remain in there current location with any refurbishment and maintenance become a priority;
- 3. All of the proposed uses on the two reserves be accommodated with the retention of all buildings. This is possible given the small footprint of especially the Infant Health Clinic building. See below Infant Health Clinic building footprint superimposed on the architect concept plan (Officer Comment see end of table for referenced plan).
- 4. If all the aspirations depicted in the architects plans are still seen to be of value, then they can still be incorporated in a development that retains all buildings. What will not be required is the addition of new building for administrative purposes. There would be a loss of two carparking bays off Price Street. However, there may be potential to pick up car parking bays by angle parking on the south side of Mitchell Street west of the Plane tree.
- 5. See following examples superimposed on architects sketches (Officer Comment see end of table for referenced documents), of 'What can still be achieved when retaining the Infant Health Clinic building and the existing Cottage Crafts building'.
- 6. If much value continues to still be placed on achieving the "interactive and vibrant streetscape" (Architects Brief 2011), then investigate achieving this directly from Strickland Street between RSL and Infant Health Clinic buildings.
- 7. Proper recognition of the heritage value of the site must be given. The officer report to council in 7 May 2013 in regard to the

	Infant Health Clinic advises "It is not listed in Town Planning Scheme No. 3 as a place of Heritage Value". 		The draft concept plan proposes removal of the existing brick 'IHC' building and part of the Cottage Craft building. These buildings contribute aesthetically and functionally to the street scape and are more appropriate in this context than the proposed area of open space.
		Best practice urban design principles prescribe massing and continual building facades for an interesting and functional mainstreet. The proposed area of open space is contrary to this.
20	Denmark RSL Sub- Branch PO Box 274 Denmark	Following notification by the Denmark Shire Council, the Denmark RSL here submits its notice and comments concerning the Plane Tree Precinct Development Concept Plan. The Denmark RSL is supportive of the general concept but believes there are some important aspects of the proposal that need to be removed or significantly changed.
	Delilliark	The Denmark RSL first submitted comments on this concept plan to the Denmark Shire on 2 <sup>nd</sup> June 2013. A copy of this submission is attached (Officer Comment - see end of this submission for referenced attachment).
		A summary of that submission is:
		The drawings incorrectly describe some of the original RSL Hall building as "recent additions".
		The drawings propose to have north facing "glazing and decking". This area comprises the RSL storage room, funds and building approval for which were granted by the Denmark Shire. Loss of this space would necessitate further additions (as additional cost) to enable the current service to the community to be maintained.
		The drawing indicates moving the descendent of the Lone Pine Tree to the corner of Strickland and Bent Streets. This would cause both short and long term additional costs.
		The drawings indicate "restoration of the façade to original design". It is not state what that comprises. However the drawings indicate that the new toilets would be of a type that resembles a shipping container with wood boards on the outside. We believe this is definitely not conforming to the "original design" or to the community heritage value of the original building.
		The Denmark RSL proposes the 6 pdr anti-tank gun be relocated to a position at the front centre of Lot 40 Strickland Street and facing Strickland Street with a cantilever cover to protect it from the elements.
		Our further submissions are as follows:
		We support the concept of the amphi-theatre. We believe there should be some protection from the weather from those using it – either with artificial or natural cover. As it is probable that it would be of most use in summer months, it is suggested that appropriate tree cover be considered.
		There should be serious consideration given to the resident, Mrs Faye Malcolm whose property adjoins the proposed concept plan. If there is to be an increase in public activity on the site, then there should be some protection from public activities affecting her privacy. That could include fencing and natural border treatment.
		We believe there are ample BBQ facilities in the town site where private residences are not affected. Putting BBQ and lighting on the proposed site would encourage late night activities and an increase in unruly behaviour. These facilities could also necessitate the provision of toilets. We believe this would detract from the amenity of the park and further impose on the privacy, mental and

physical safety and welfare of the resident, Mrs Malcolm.

The Denmark RSL has recently met with you and the Shire Finance Officer, Mr Kim Dolzadelli concerning the RSL's proposal to refurbish the Denmark RSL Hall building. We will be seeking funding for approximately \$220,000. This refurbishment will greatly enhance the outlook of the building and site and will complement the Shire's Concept Plan for the area. We will be seeking funding from all possible sources including the Denmark Shire. We hope the Shire Council will consider our funding request not as a benefit for the Denmark RSL but as a benefit for the community.

We consider the comments we have made in this submission are of importance, not only to the RSL, but to the community of Denmark, and of Heritage value to the State. We urge the Denmark Shire to take this submission into consideration and urge you to discuss these matters and the proposed Concept Plan in greater detail prior to commencement of works on the plan.

#### Attachment: 02 June 2013 Submission:

Following the architect's concept design of the Plane Tree project, the Denmark RSL submits some observations and concerns about the points made in that concept design.

- 1. On the referenced drawing, with reference to the RSL Hall, it indicates that "Current Additions {be} removed. We advise that these are NOT current additions and are part of the original building. The part of the building referenced here as those "current additions" comprise a ladies toilet and the RSL members' meeting room.
- 2. On the referenced drawing, with reference to the RSL Hall, it indicates the "proposed restoration of the original façade". It is unclear what the intent of this proposal is. The RSL believes it may be in reference to the verandah addition covering the rear two doors. The Denmark Shire gave building approval for this verandah in order to protect the two doors that regularly deteriorate due to the prevailing weather from the Southerly direction.
- 3. On the reference drawing, with reference to the RSL Hall, it is proposed to have "Northern glazing and decking". This area comprises the RSL storage room, funds and building approval for which was granted by the Denmark Shire.
- 4. Should the proposals mention items 1 and 3 above be actioned, it will mean a total loss of approximately 38m2. There is not a similar space indicated on the referenced drawing to replace this loss of space.
- 5. The drawing indicates the pine tree, which is a direct descendent of the "Lone Pine" at Gallipoli is to be moved to the corner of Bent and Strickland Streets. It is suggested that the overhead power cables will need to be relocated and that the tree being so close to the building will cause the gutters to collect significant detritus. Both of these issues will incur short term and long term costs. It is suggested that the Lone Pine, situated where it currently is, would form a pleasing aspect of the community space and not produce so much maintenance to the building.
- 6. The Denmark RSL has previously submitted to the Denmark Shire drawings for a cantilever canopy over the Anti-Tank gun to minimise effects of climatic deterioration. The Anti-Tank Gun has recently been restored to a much improved condition at considerable cost to the Denmark RSL.

With regards to the possible loss of the storage room, as indicated in the proposal, with replacement location must be provided prior to works commencing on the concept changes. It will not be manageable if the storage room was withdrawn without the replacement storage facility being available.

On previous communications with Shire Officers the RSL has suggested that Bent Street be widened to provide extra parking. The RSL still believes that this will be of benefit to the community without detracting from the functionality of the RSL Hall or facilities. Vehicle currently park partly on the verge and partly on the road to provide passing room for vehicles. Consequently the ground on the verge is of no benefit for a garden as it is regularly compacted by vehicles. A widened verge would allow the preparation of an attractive garden, more parking and maintain sufficient width for vehicles to pass.

		The RSL believes that the owner of the house behind the RSL, Mrs Faye Malcolm, also suggested parking alongside her residence.
		At a recent discussion between shire officers and the Denmark RSL, some of these points were mentioned and deemed minor detail. The RSL submits that they are significant aspects that can have a big impact on RSL operations and the ability to provide services to the community. The RSL requests that these points be discussed in detail before any plan for the precinct is finalised as proper planning prior to the execution of a plan will minimise waste of both time and finances.

	Denmark	The shaded walkways are too fussy and the shade would shift all day. On rainy days they may not provide much protection if windy. Dripping rain would be an annoyance too. I feel they block the Precinct, rather than visually invite passers-by.
		The RSL building – the current store room on the west/nor/west side does not need demolishing, however the storage could be incorporated elsewhere within the building (no need for a new store room on the rear) and the current room opened up to take in the activities outside, by incorporating a picture window and door. Instead of a deck, a small verandah (reflecting the design of the Denmark Cottage Crafts verandah) with ramp and steps would create interest and inclusion. This could become the main reception area for the RSL. This window needs to have some solar passive considerations incorporated.
		The BBQ/Play area is unnecessary – however the amenity could be improved with plantings to attract birds, some seating, shade and wide paths with good lighting (solar lit paths) to dissuade loitering and graffiti. Some public art would be appreciated and perhaps some children's artwork (engraved slabs or tiles) or historical dates and settler names. Something to commemorate (move the time capsule back to this location for safe keeping) educate (colourful story boards about wildlife) and inspire visitors.
		Should the Child Health Centre be retained, following appeals, then the landscaping and an inviting entry statement would help bring the amenity together. The child Health Building can be re-purposed for the RSL/Denmark Cottage Crafts. Certainly the Plane Tree needs to be a focus and perhaps shaded seating could be attached to the rear of the Child health building. Perhaps the Child Health Building could be made a pop-up shop space (or pop-up restaurant)? Main consideration is no wind-tunnels or areas for trapping litter. Efforts need to be made to reduce opportunities for concrete/paving to go mouldy/slimy. The building appears very damp.
		The Denmark Cottage Crafts group main entry should have a verandah where family can sit while their loved ones shop for crafts. Crafts are important, but they are not every man's cup of tea! As plant sales are a big attraction the group should have an easily accessible/lockable outdoor spot, with access to running water and a work bench/storage facility for hose and buckets. It would be good to have this amenity under cover, yet well sunlit. No one needs to shop in the rain.
		The overall historical square needs further traffic management with the proposed parking behind the Denmark Cottage Crafts, made one way with angled parking. Unsure how the traffic should flow, but the corner opposite the Red Cross shop is difficult to negotiate even at quiet times!
		Regarding the amenity and privacy of the owner of lot 42, I feel her rights should be regarded. Clearly no one would like to see

		Mrs Malcolm hounded out by noise or fears for her safety. Consideration of appropriate lighting needs to be made (especially in the space between her home and the proposed new parking area at the rear of the Craft Shop. Within 10 years or less, the resident may decide to move on. At her home is also of historical significance – I feel every regard should be shown to her and in the long run, the home could also be incorporated into the precinct (a museum space?).
		This plan is exciting and the precinct is a sad wilderness of lost opportunity at the moment. Denmark is without a focus apart from the river side and the War Memorial. This special space has much to offer and I and many others are hopeful of a timely development which should bring benefits to locals and visitors alike. The retail sector in the main street should also see benefit.

		As the meeting was arranged to review the community's submissions, it was not the forum to discuss an alternative proposal the Cottage Crafts had developed for the overall Precinct since the last meeting, and which we believed was generally reflected in the various submissions. Consequently the meeting kindly agreed for us to put our revised proposals to the Shire in writing.
		At the hub of our proposal is the retention of the old Infant Health Centre building which to-date, leaves me standing alone in the Working Group, as it does not appear at all of any interest to the rest of the group, some of which think it is 'ugly' (mentioned at a previous meeting) and 'unremarkable' (from the MHI). In defence of the IHC, ugly and/or beauty is neither a factor of value in history/heritage and I don't think anyone could describe the RSL Memorial Hall, CWA or many other buildings on the MHI as attractive or beautiful. What is important is the provenance, and what the community created.
		The naysayers expressed the opinion the IHC building is beyond repair and not worth keeping, yet the Arts Council have been using it for years and the MHI of 2011 recorded the condition as 'good' and the level of significance as 'considerable'. It is has, as suggested, deteriorated that badly in the last three years, and possibly unsafe, then surely it should have been rectified or the tenants removed. That is simple logic and our defence for retaining and repairing the building.
		Furthermore, and more to the point, it would appear that to demolish the IHC and dress the bricks for use in the construction of the planned amphitheatre would be far more costly than to repair it and offer it for use by another community group. We already know of one group that could be interested in it. This would obviously delete the need for the amphitheatre which, in our and other opinions among the submissions is unnecessary on an exposed and potentially hazardous location when in use, which would

possibly be nil in the winter. The crossroads there are constantly used for U-turns by vehicles who often mount the footpaths in their last-minute decisions to go the other way! I saw three instances of this only this morning, just walking past through town.




Figure 1 as Referenced in Submission 23




Fig.1 Cottage Crafts alternative plan

Consequently we propose an alternative plan, which is shown in a simple and basic form in figure 1 below (Officer Comment – see end of table for plan).

Our proposal is to relocate the Cottage Crafts/Old School between the RSL Hall and the Infant Health Centre and make the Precinct a Heritage Park, with appropriate signage depicting, in general, the exceptionally high level of significance of the buildings in the adjacent area and, in particular, the Plane Tree Precinct which, I am sure, the Historical Society would be only too happy to produce.

The buildings in the close vicinity include St Leonard's church, the Red Cross Shop, CWA and the Museum, Dr James' rooms etc as well as the Precinct's own buildings and sites. The proposal would fill what the Shire has previously considered a 'commercial void' and, at the same time, generate extra parking places. The Precinct, incidentally, is also the site of Denmark's first school.

Melanie (of Pixel Trix) quite correctly pointed-out to the meeting that retail outlets really need to be at footpath level, although I noted that there is an existing 'service' footpath off Mitchell Street to the RSL Hall.

It was around that stage of the meeting that Pixel Trix presented their own alternative proposal, which also included the retention of the Infant Health Centre shown in Figure 2 (Officer Comment – see end of table for plan).

It is worth noting that the additions to the RSL Hall may not be necessary as RSL are seeking funding to make their own changes to their building (refer minutes not available at this time).

Should the Shire and/or Working Group reject Cottage Craft's relocation proposal (Figure 1) we would fully support Pixel Trix's alternative plan (Fig 2).

In conclusion, we hope we have shown how keen we are in recognising and promoting Denmark's heritage and how passionate we are, together with the Denmark Historical Society, in retaining the old Infant Health Centre building and, whilst we have not spoken to the Historical Society on this matter, we are as one with their position, and hope they will be involved at some future date to assist identification and setting-up appropriate and attractive interpretive signage. We would assure you that, in addition to the submissions tabled, we have spoken to many members and townsfolk over the intervening months who also feel the IHC should be retained.


Please forgive the length of this screed, but we fear that should the town lose the IHC building or any other on the MHI, it will be a move that can never, ever, be reversed.

# Additional Submission #2 Correspondence

Further to a telephone call from Annette Harbron re letter sent by Gordon Harris dated 16 August on behalf of Denmark Cottage Crafts, regarding the Plane Tree Precinct Development Concept Plan, I wish to clarify some of the comments made in this correspondence.

As another option to the development plan the Craft Shop Committee would like to see the Craft Shop relocated between the RSL Hall and the Infant Health Centre building, facing Strickland Street. If the Infant Health building was renovated and linked to the Craft Shop, it would be very useful to our members for meetings, storage etc.

		However this suggestion for the shop relocation does not mean that the Infant Health Centre building would need to be retained as indicated in Mr Harris' letter. Retention of this building was not, as suggested, pivotal to our new proposal.
		A bonus to the above option would be an increase in the parking area indicated on the original concept plan.

#### Patterns - Attachment 1

Some excerpts from Alexander et al. 1977, A Pattern Language, Oxford University Press:

- A public outdoor room, "a partly enclosed place, with some roof, columns, without walls,
  perhaps with a trellis" is a subtly defined place around which a diversity of activities can
  develop. To be successful, this room should be "beside an important path" and "within view
  of many homes and workshops" (p.352).
- "Dancing in the street", that most wondrous of community activities, is facilitated by the
  presence of a "slightly raised platform to form a bandstand...cover it...[and] surround the
  bandstand with paved surface for dancing" (p. 321). To be successful, this performance
  space should be near to food and drink stands, located towards the edge of a square or
  promenade, be defined as a public outdoor room would be, and perhaps have coloured
  canvas canopies over the dance floor.
- A public square is a core activity node for a town. To work, it should be no more than
  20 metres wide: this relates to a comfortable density of people who are likely to gather
  there. If it is larger than this, it can seem deserted, and uncomfortable. As well as a small
  size, the square must be located along the intersection of paths that are often used by
  people: they need a reason to find themselves there.
- A street café gives identity to the public square. It is a "unique setting...where people can sit
  lazily, legitimately, be on view, and watch the world go by" (p. 439). It works best when set
  up with several (indoor and outdoor) rooms, open to a busy path and perhaps spilling to the
  street.
- "The life of a public square forms naturally around its edge. If the edge fails, then the space
  never becomes lively" (p.600). This means that attempts to create activity in the centre of a
  space will tend to fail. Rather, create small, partly enclosed areas at the edge of the place,
  which "jut forward into the open space between the paths, and contain activities which
  make it natural for people to pause and get involved" (pp.601-2).
- "Outdoor spaces which are merely 'left over' between buildings will, in general, not be used"
  (p.518). Giving outdoor spaces some degree of enclosure will give it a positive quality and
  make it more useable.
- "Outdoors, people always try to find a spot where they can have their backs protected,
  looking out towards some larger opening, beyond the space immediately in front of them"
  (p.558). So, one should "open up public squares and greens, at one end, to great vistas [so
  that] the square itself acts as a kind of back which a person can occupy, and from which
  [they] can look out upon an even larger expanse" (p.559).
- Small parking lots are safer, more sympathetic to the pedestrian realm, convenient and help maintain green streets. The Pattern Language suggests optimal lot size of about seven car spaces.

It has been sadly neglected and I'd like to find out why when ratepayers' money is spent on much less important things. I found the syntenire solid with a pleasant outrook once the overgrown bushes are removed and replaced with new landscaping.


Shift to the centre



#### 3 KEY CONCEPT DESIGN ELEMENTS:

# 1. DENMARK HERITAGE ART PARK & PERFORMANCE SPACE:

The central location of the site - within Denmark CBD & at junction of Strickland St Heritage Precinct & Mitchell St Heritage Precinct - offers great opportunity to create a vibrant community space.

This space could highlight the many talents Denmark has to offer and additionally provide a link to the past.

The level change invites the layout of an amphitheatre that creates areas for resting, reading, lunch, meeting, street performances and much more.

Early ideas include a circular plant layout to showcase the six local Aboriginal seasons with incorporated artwork in the seating and paving. Possibly a way finding compass could be included into the paving to help orientate visitors. Both heritage precincts could have common ground here as a meeting place to start and end heritage walks.

A strong link to the Infant Health Centre would be incorporated as this proposal requires this building to be removed. The historical and local importance of the building could be reflected in many ways. Artefacts such as measuring sticks could be part of the amphitheatre as well as reusing the bricks of Denmark's first government brick building. This could be explained with interpretive signage.

Beyond the amphitheatre the Heritage Art Park would continue into more quiet and elevated BBQ facilities protected by shade sails. This area could also incorporate heritage play equipment as well as sculptural art play equipment. The key idea is to create a low key family environment with respect to adjoining neighbours.

Another area where the theme of history and art can be continued is the proposed modular covered walkway. This walkway provides weather protection on the western side of Strickland St and is a reference to the already active walkway on the eastern side. This walkway could become a linking spine that bridges the gap from the Pharmacy canopy to the Doctor's surgery. Being modular and small in scale this walkway could be provided in places suitable and follow the contours of Strickland St and create its own broken up landscape of angled roofs.

# 2. RE-INSTATEMENT OF HERITAGE BUILDINGS:

The Denmark RSL Hall and the Denmark Cottage Craft (including Carmarthen School) form an integral part of the built and social fabric of the town.

To be easily recognised as heritage buildings the concept plan proposes to bring back these two buildings as close as possible to their original design. Later additions would be removed and the facades of both buildings restored. The necessary administration, amenities and storage facilities could be added as contemporary smaller additions that are placed in the background with sympathetic designs in relation to the original buildings.

Both buildings are proposed to open up into the new community space with a verandah (as shown in earlier photos of the Carmarthen school) and with a generous deck (RSL). In particular the deck on the northern side of the RSL hall would offer a sunny place to sit and enjoy the connection to the other facilities and the town beyond. In addition the large northern glazing would enhance the RSL hall not only thermally, but also in its usage. This would enable this building to become an even greater community asset.

# . CBD CAR PARKING/ ACCESS:

This Concept Plan provides for much needed CBD car parking and at the same time acknowledges the problems that come with sealed parking bays. The majority of the 21 proposed car bays are located behind the re-instated Carmarthen School building and offer 14 car bays including one disabled car bay. This part of the car parking is proposed to be made out of trafficable grass pavers. Apart from providing a natural surface these grass pavers allow storm water to disperse and provide a cooler surface in summer. Added shade trees would enhance this space further and make it feel as being part of the Heritage Art Park.

There are 3 further car bays proposed for a more formal parking near the RSL back entrance (including one disabled). And finally some additional 4 car bays could be provided along Bent St. This arrangement is shown pending a Bent St review.

With regards to disabled access; the accessibility was a priority consideration for this concept. Two ramps were included to allow for direct access from Strickland St and from Mitchell St. The paths throughout are considered to lead from different areas with appropriate fall to allow for easy access to any part of the precinct.

# DENMARK RSL HALL REFURBISHMENT DETAILED REQUIREMENTS

#### Overview

The Denmark RSL Hall exterior is to be restored, existing toilets are to be demolished and new toilets are to be constructed. The Hall is of significant heritage value especially to the town community. That heritage aspect is to be respected and maintained and the works should reflect that.

The building contractor shall be responsible for any and all insurance required for the works.

The Denmark RSL Hall site is used for community activities. If the contractor considers part of the works will impact on those functions/activities in the hall, the contractor is to notify the Denmark RSL who will liaise with the participants and make suitable arrangements.

The works are to be completed within 3 calendar months of the awarding of the contract to the contractor. The Denmark RSL reserves the right to complete unfinished works with alternative contractor(s) and on-charge the costs to the defaulting contractor.

The Denmark RSL will apply for and pay for any council or government agency building permits or fees that are due for these works.

The elements of this project are:

# Toilet Upgrade

The existing toilets are to be demolished and replaced with new design toilets. An access ramp to disability wheelchair requirements and a screened access way in the main hall are to be constructed. Two existing internal walls removed where indicated on the plans and the internal structure to be made good with the exception of internal painting on the walls where the removal of existing walls is performed. All new walls are to be painted on internal and external surfaces. External surfaces are to be painted in colours similar to those existing. Internal walls are to painted in colours as detailed by the Denmark RSL.

The external appearance of the finished toilet additions are to look as the same style of the existing building in terms of eternal walls and roof type. Additional gutters are to match and align with existing gutters. Downpipes are to be installed as per drawing.

Alternative toilet facilities are to be made available by the contractor during construction.

#### Details:

- Termite treatment is to be applied where necessary.
- 2. Electrical works are to be installed by a qualified tradesperson.
- 3. Water, sewerage and gas works are to be by a qualified tradesperson.
- 4. The HWS is to be positioned as specified by the plumber in accordance with regulations. The gas supply for the HWS is to be taken from the existing gas bottles on site.

- 5. The hand basin and pan etc. in the existing Women's/disabled toilet are to be recovered and used in the new women's/disabled toilet. Other basins and pans are to match.
- 6. The external doors are to be fitted with keyed locking mechanisms.
- 7. The external glass door at the top of the ramp is to be double glazed.
- 8. Thermal insulation is to be installed to the standard and requirement of local building by-
- 9. The site is to be left in a clean and tidy condition, free of rubble etc.

# **Rock Work**

The existing rock wall adjoining the Strickland Street pavement is to be extended up both sides of the main steps, leading up to the Hall entrance from Strickland St. The finish is to match as close as possible the existing rock work aligning the pavement. The width and height of these walls is to be the same as the existing walls and butt in to the existing walls. The walls are to finish level with the top of the 4<sup>th</sup> step at a level when finished as described in the next paragraph, (as shown in picture 1 and 2) and follow the edge of the existing concrete steps and access path. The base course of rock work is to be bedded in concrete footings of 500<sup>mm</sup> x 300<sup>mm</sup>. The footings shall not be visible above ground level. The walls are to butt into the side of the RSL Hall foyer at a level of the finished top step as per below.

#### Steps

The four top steps as shown in picture 3 are to have the concrete slabs removed. The vertical and horizontal surfaces of all the steps leading up to and including the main entrance are to be cleaned, washed with bondcrete, and finished with a "Granolithic" or "exposed aggregate" type surface  $60^{mm}$  thick. The four steps where concrete has been removed is to have  $60^{mm}$  plus the thickness of the existing concrete slabs. The existing "painted" entrance foyer is not to be changed.

# **Gun Position**

A rock wall is to be constructed (as per the discussion with the Denmark RSL and drawing attached) for the New Gun Position, in front of the existing Lone Pine Tree descendent. The finish is to match as close as possible the existing rock work aligning the pavement. The width and height of this wall is to be the same as the existing walls. The base course of rock work is to be bedded in concrete footings of  $500^{mm} \times 300^{mm}$ . The footings shall not be visible above ground level. The inside of the rock wall is to have suitable drainage to allow water inside the wall to escape through the lower course work or footings. The drainage to be in the form of slotted  $90^{mm}$  PVC pipe, placed in blue metal with an outlet through the footings. The inside of the rock wall to be compacted to 9 blows with a penetrometer in  $150 - 200^{mm}$  layers.

A cover is to be constructed as per the attached drawing and then erected on site. The location of the gun cover will be shown on site to the contractor by the Denmark RSL. All welded joints of the structure are to be properly welded, ground and treated with a rust inhibitor prior to priming and painting.

The Denmark RSL will supply the artwork for the RSL Logo to be placed on the front of the gun cover when required.

#### **External Painting**

All external paintwork of the existing RSL Hall is to be painted in colours to match existing. Loose or flakey paint is to be removed. Bare wood is to be primed. All other painted surfaces to be cleaned and sanded and prepared for re-painting as needed.

NO existing bare brickwork is to be painted.

Any existing material/surface considered to require replacement is to be brought to the attention of the RSL Denmark who will decide what action is to be taken for each situation. Costs for such extra "replacement" work will be borne by the Denmark RSL at a price agreed between Denmark RSL and the contractor.

# Safety

The contractor shall take appropriate safety measures to ensure protection for the passing public and patrons using the Hall.

#### Drawings

These details are to be read in conjunction with the drawings. Any deviation from the drawings is to be confirmed in writing by the Denmark RSL and the builder prior to work on any deviations commencing.

The Drawings remain the property of the Denmark RSL Sub-Branch and are to be returned to the Denmark RSL on demand.

The contractor is required to initial and date each page of one copy of these **DETAILED REQUIREMENTS**, pictures and drawings and return to the Denmark RSL with their quote.
