# Policy Review: Ag College Scholarship P080201

Review date: June 2018

## **Summary:**

The purpose of the Agricultural College Scholarship is to encourage Y10 students with an interest in agriculture to pursue higher education. The Scholarship is offered to Shire of Denmark residents intending to complete Y11 and Y12 at the WA College of Agriculture - Denmark

Policy P080201 states that: Council shall make available an annual Denmark Agricultural College Scholarship. The scholarship value is \$1000 to be paid out over two years at the commencement of Y11 & Y12.

This policy was last reviewed and amended in March 2011.

The current application process requires students to submit a handwritten application form including a 50 - 100 word personal profile stating a reason why they believe they should be awarded the scholarship.

The number of applicants over the past five years have been variable. The largest number of submissions was received in 2015 with 12 applications. An overview of applicant numbers is outlined below:

The ability to submit applications online is now common practice. The need for a 50-100 word statement could be complemented with the choice of a more up to date method, such as a short 30 second video. The ability to upload the content online as part of the submission process should also be offered.
Applicants	In 2017 6 students applied for the scholarship.	After reviewing the 2017 applications, it has been noted that all students who applied for the scholarship were already attending Denmark Agricultural College in Y10.  The original intent of the scholarship to encourage Y10 students to complete Higher Education at the College appears to have shifted. Students with interest in Agriculture can now also complete Y10 at the Agricultural College and are choosing to attend the College at the completion of Y9. In 2018 there are 11 Denmark resident students already attending Y10 at Denmark Agricultural College. The pool of applicants for the 2018 scholarship will be primarily this group of students.  Offering the scholarship to students that reside in Denmark who are commencing Y11 at Denmark Agricultural College only, limits the pool of applicants.  Including students at the commencement of Y10 may increase the pool of applicants.
Feedback	Steve Swallows, A/ Principal WA College of Agriculture - Denmark	Steve stated that the Scholarship is a welcome assistance for students. He explained that the scholarship is promoted within the school. He did not consider the application process to be too difficult. Steve thought some students did not deem themselves to be good candidates to be awarded the scholarship or may have been too busy with end of term assessments and therefore decided not to apply.

		He said some students might also not have been aware of the scholarship. He explained that offering the scholarship to students that reside in Denmark only, limits the number of applicants. He suggested selecting the correct timing for calling submissions is critical, so that it does not clash with end of term assessments or school holidays.

# **Risk Analysis**

Risk	Risk Mitigation
Short timing for calling of submissions, clash with end of term assessments and holidays.	Call for submissions as soon as possible, allow for sufficient time for promotion and student response.
Lack of interest, low number of applications.	Target eligible student pool direct, refresh application process. If Y10 included target Y9 DSHS Students direct through Student Coordinator.
Discontinue Scholarship	Negative community feedback, less perceived Shire support for youth and agriculture. Does not fulfil our community aspirations set out in Denmark 2027, E1.3, E1.4 and C4.1.

## Recommendation

That the Shire of Denmark continue to offer the Agricultural College Scholarship. That students intending to complete Y10 at the WA College of Agriculture – Denmark also be eligible to apply for the Scholarship.

- c) Preference will be given to those students who are likely to continue agricultural pursuits within the Shire boundaries.
- d) The Scholarship amount will be determined by Council and 50% will be paid at the start of the first year and upon successful completion and continuation, 50% will be paid at the start of the second year.
- e) The CEO and/or the Shire President address the Seniors School students at the commencement of the advertising of the program (generally in September) to promote the Scholarship;
- The Sponsorship be widely promoted in local papers, notice boards and Council's website to both potential nominees and their parents or guardians;
- g) A Scholarship will not be awarded if no applicants are suitable.
- h) The decision of Council and/or the delegated Committee shall be final.
- i) The closing date for applications will be determined each year by the CEO to allow sufficient time for determination of the winner by Council and presentation at the relevant school's graduation ceremony.
