2. **REPORTS & PRESENTATIONS**

2.1 Wilson Inlet Catchment Committee (WICC) Update

The Executive Officer of Wilson Inlet Catchment Committee, Shaun Ossinger, provided an update on the Wilson Inlet Management Plan. This included the current challenges in respect to nutrient mapping and controls, achievements and the implementation strategy and objectives for the future. The future focus is on revegetation, particularly of waterways, and working with volunteers to achieve up to 50ha of plantings.

2.2 Norm Thornton Park tree stump (proposed art project)

The Director of Assets and Sustainability, David King, discussed the condition of the tree stump, which has wood borers, located next to the bridge in the Norm Thornton Park. Unfortunately it is no longer suitable for a public art installation. A press release will be issued prior to its removal.

2.3 Dog Policy Review

The Director of Assets and Sustainability discussed the proposed strategy for a comprehensive review of the Shire's Dog Policy.

Councillors requested staff review whether the Cat Local Law caught be bought forward and completed at the same time. Staff will review and advise accordingly.

2.4 Opening of facilities with stage 3

The Executive team shared the planned re-opening of shire services. This will involve a transitional approach for the Administration building front counter, Library, Recreation Centre and Parry's Beach campground.

The Rangers have also re-opened playgrounds, bbq's and other public amenities.

2.5 Funding opportunity (\$349K)

The Acting CEO and Director of Assets and Sustainable Development outlined suggested projects with a priority listing for progression. The intent is to leverage further funds from State and/or Federal Government.

2.6 Visitor Servicing

The Acting CEO and Project Officer, Kristina Low, addressed the briefing note supplied to Council on potential options for Visitor Servicing moving forward with the Amazing South Coast Tourism Inc. divesting itself of the Denmark Visitor Centre.

Discussion provided direction for staff to continue working with the Denmark Chamber of Commerce to further facilitate discussion with the tourism industry.
