### 2. REPORTS & PRESENTATIONS

### 2.1 Community Financial Assistance Program

The Executive Manager of Community Services, Angela Simpson, provided updates on the Community Financial Assistance Program applications received. Council will be asked to consider the officer recommendation at the July OCM.

### 2.2 Rate Modelling for 2020/21 Annual Budget

The Executive Manager of Corporate Services, Lee Sounness, presented the rate modelling for 2020/21 Annual Budget. The indicate rate in the \$ was presented for each category to achieve Council's stated objective: "If changes to the Shire's rating model (occur) rates in the dollar, valuations or other changes lead to a rates bill for an individual rates assessment which is greater than it was in 2019/20, then the increase shall be reduced to zero via a waiver of rates equal to that amount except where such increase is due to improvements or development on that property resulting in a valuation increase".

The advertising process and timeline leading into the budget adoption (Special meeting 4 August 2020) was also discussed.

The Acting Chief Executive Officer, David Schober, and Project Officer, Kristina Low, updated Council on Amazing South Coast Tourism Inc's interim plan to keep the Visitor Centre open throughout July.

### 2.4 End of Financial Year position

While the final details are not yet confirmed (this will take a further 10 days) it is likely the final amount will be significantly more positive than expected. The increased and significant surplus returned is due to a number of contributing factors and staff will present a special briefing at the Budget briefing on July 14.
