#### 7. REPORTS

#### 7.1 MOKARE WALK TRAIL

At the last meeting Mr Boyes requested an update on the possible upgrade of the Mokare Walk Trail.

Mr Boyes discussed the condition of the Mokare Walk Trail since the last bout of bad weather and advised that he had spoken to a Shire Ranger about it.

Cr Osborne asked whether any signage had been erected to notify users of water over sections of the path.

Mr Hill asked Mr Sounness if the Shire had any reports on upcoming pedestrian path upgrades. Mr Sounness advised that within the draft Budget for 2021/2022 there was an allocation of funding for new footpaths.

#### **Outcomes**

- 1. Officers to put through a request for the current condition of the Mokare Walk Trail to be investigated
- 2. Information regarding future upgrade and renewal of existing footpaths would be discussed with the Director of Assets and Sustainable Development, and provided for information with the next meeting agenda.

#### 7.3 INTERNATIONAL DAY OF PEOPLE WITH DISABILITY

The International Day of People with Disability (IDoPwD) is held annually on the 3 December and in the past the Shire has coordinated a community event in recognition of the day. Events should involve and celebrate people with disability.

Attached was an Event Planning Kit that had been downloaded from the IDoPwD website.

Mr Hinds suggested a collaboration with neighbouring Shires with regards to the IDoPwD. To share information regarding events being held within the region, with the view of perhaps facilitating collaborative events.

#### 8. GENERAL BUSINESS

#### 8.1 ACCESS RAMP TO THE DENMARK PHARMACY

Mr Hinds raised concerns with regards to the access ramp outside the Denmark Pharmacy and said that he believed it needed replacing.

Officers noted that although the Committee can request Council to liaise with the Denmark Pharmacy, the Denmark Pharmacy is not at liberty to implement suggestions.

#### 8.2 BEACH WHEELCHAIR

The Community Development Officer presented to the Committee correspondence received from the Denmark Surf Club in relation to the Beach Wheelchair currently stored at their Club.

In the letter, the Surf Club had advised that the wheelchair was extremely difficult to manoeuvre down the beach and rarely used, and the Surf Club were no longer able to house the beach wheelchair in their shed due to limited space. The Denmark Surf Club sought clarity from the Committee on what they would like to do with the equipment.

The Committee discussed the possibility of alternative use and that it may be more beneficial to another community group.

Mr Sounness advised that the existing plan was a concept only and once funding is available, design elements around accessibility could be provided to the Committee for their comments and suggestions.

#### **8.7 CHURCH PARKING PLANS**

Mr Hinds spoke about proposals that he believed the Shire had received, and referred to the location of disabled parking bays. A general discussion regarding placement of disabled parking bays ensued.

Mr Hinds requested that Council decline the bay location of the current proposal.

Mr Hill noted that the Committee were not able to suggest any changes to plans that are only in concept and have not yet been passed by Council.
