2. REPORTS & PRESENTATIONS

2.1 Denmark Historical Society Site Visit

Denmark Historical Society hosted Councillors on a tour of the premises and outlined the Society's role in preserving the history of the Shire and region. The membership presented the Deputy Shire President with a cake in recognition of the 110th anniversary from when the Denmark Roads Board was formed in 1911.

2.2 WALGA Energy Proposal

The Deputy CEO discussed the WALGA joint purchasing agreement with Synergy as a result of the administration building becoming a contestable site. While this program can provide savings it requires a three year contract with Synergy and precludes the opportunity to purchase from other suppliers. Staff are waiting for a contract offer from Synergy and will investigate other available options in the interim before making any purchasing decisions.

2.3 Reconciliation Action Plan

The Corporate Planner and Executive team discussed the steps in developing a Reconciliation Action Plan (RAP). This requires extensive community conversations, including engagement with Indigenous stakeholders and agencies, with the timing to be considered according to the feedback received. Councillors acknowledged that a respectful and carefully considered process will take time and that a RAP will not be completed by March 2022, as required by the CEO Key Performance Indicators.

2.4 Denmark Surf Life Saving Club and Prawn Rock Channel (Ocean to Channel) Project

The Deputy CEO shared an update with Councillors on the next steps in securing funding (Round 6 BBRF), including options available if the grant is either successful, or unsuccessful. The Coastal Engineer engaged by the Shire is still completing an updated Coastal Hazard and Risk Mitigation Plan, this should be completed prior to Christmas. Future site planning was also discussed with possible options considered. Councillors were also informed that further information on the outstanding insurance claim, which resulted from the winter storms, will be shared as it comes to hand.

2.5 Local Government Reform

The Governance Coordinator shared a brief summary of the draft Local Government Reform process, now out for consultation.

2.6 January 26, 2022 Event

The Manager of Community Services and Community Development Officer discussed planning for the 2022 event, including a funding application for \$10,000. Councillors provided feedback on expectations for the 2022 and 2023 events. While planning is well underway for the 2022 event, there is a desire to consider community sentiment for the 2023 event.
