The local indigenous community representative for Denmark as advised by the Department of Indigenous Affairs (DIA) is Wayne Webb. Wayne was part of the initial steering group committee and assisted staff in the sighting of the proposed trail course.

The Shire has corresponded with DIA in the planning of this project. DIA noted that generally the Council was aware of and addressing Aboriginal Heritage. However, advised the Shire on who how to proceed with the project should further development activities occur.

Recently members of the Albany Aboriginal Heritage Reference Group (AAHRG) were consulted about the trail. Ms Treasey Woods spoke for AAHRG and supported the project. Ms Woods stated that she believed it would be impossible to stop people visiting Poison Point and therefore it was better to define a 'suitable' track than allow current practices to continue. Ms Woods's approval was subject to the continuation of Indigenous advice and involvement of a local Indigenous Monitor in the final (ground truth) alignment.

Restoration of Poison Point and Access Restriction

Description

1. Provide a brief description of the project including how it will be carried out.

The project brief is to aid restoration of the riparian zone at Poison Point by providing a sustainable walk trail and vehicular access to Poison Point. The project aim is to enable the riparian zone to regenerate by reducing the current pressure exerted by visitors to the Point's foreshore.

The project objective is to restrict access to sections of the existing walk trail and road so as to minimise the current deleterious impact on the riparian zone. The intention is also to manage vehicular activity by restricting vehicles and parking to the first embayment area, while allowing visitors to access the Point via a designated walk trail.

The trail and road will be surveyed and pegged after final consultation with stakeholders. The reconstruction works will be implemented by a local contractor under the direction of the Shire's, Infrastructure Services and Planning and Sustainability Directorates. The Shire will rehabilitate sections of the riparian zone focusing on areas of the trail and bank.

Ongoing management and surveillance will be provided by the Shire of Denmark with the support of the local community.

3. Who owns the asset?

The Poison Point Reserve is Crown land and vested in the Shire of Denmark.

4. What are the threats to this asset and what has been done to address these threats?

Currently the main threats include:

- Rapid soil loss and soil erosion following torrential downpours and sheet flows due to the steep slope
 and incised and un-stabilised surface of the existing 4 wheel drive access. Subsequently eroded soil
 may contribute to sedimentation of the Inlet.
- 4 wheel drive vehicles continue past the first embayment and proposed vehicular parking area and proceed along the existing section of walk track widening the track, destroying vegetation, compacting soil and 'tearing up' the walk trail.
- Trampling of understorey and fringing vegetation by tourists, local recreational walkers and recreational fisherman as they traverse across intact vegetation creating multiple tracks and venture around the bank edge of the point.
- Multiple vehicle and visitor made tracks in the riparian zone along the foreshore and on the edge of the bank result in exposure and damage to the understorey and tree roots causing soil compaction and soil erosion of Wilson Inlet. There is also loss and decline of fringing vegetation.
- Vehicles are currently parking in several locations at the first embayment and at two embayment's
 further down the walk trail. This vehicular activity is incrementally increasing the parking footprint(s)
 due to lack of a defined 'permitted' parking area. This causes soil compaction in the trees' drip zone
 and damages roots, buttressed trunks, understorey and fringing vegetation resulting in the death of
 some tree species and areas of rushes and sedges.
- Dieback, *Phytophthora cinnamomi*, is a potential threat to the Poison Point Reserve. Mapping has identified the presence of Dieback in nearby Shire Reserves. The unsealed pitted and incised existing access road may act as a vector for the spread of dieback to Poison Point Reserve as water pools on the irregular surface (exposed laterite and clay) and the Reserve is down slope from the road.
- Acid Sulphate Soils (ASS). Wilson Inlet has been identified as 'high to moderate risk' (WIFRMP, 2008)
 within three metres of the natural soil surface. The persistent vehicular activity and creation of incised
 tracks on the 'Point' could result in exposure of ASS.

5. Why is the asset important to your group?

This Reserve is identified in the Shire of Denmark's amended 'Wilson Inlet Foreshore Reserve Management Plan 2008' (WIFRMP) as 'a beautiful place, with unspoilt vegetation and extensive views of the inlet'. However, the management plan goes on to explain that the 'steep and partly eroded' walk and vehicular track limit accessibility.

Council resolved (Res: 110511) at the Ordinary Council Meeting, 24 May 2011 to apply for funding to cultivate Poison Point as a recreational node while ensuring minimal disturbance to the adjacent vegetation.

Measurement and Maintenance of Results

1. How will you determine whether you have addressed the problem?

The Shire of Denmark will assess if the problems been addressed by the following indicators:

- Reduction in soil loss and in soil erosion following rain events and 'torrential downpours'. This
 should be evident at site inspection following significant episodic rainfall events.
- Cessation of vehicles encroaching on the walk trail. Any breach will be apparent as bollards will be installed with concrete footings and a keyed gated installed (fire access).
- Amelioration of riparian vegetation evident by a reduction in the number of plant deaths and an
 increase in species density. This will be apparent in, and recorded by, a photo point monitoring
 program. (Initial photos to be taken just prior to commencement of the project to ascertain the
 extent of current vegetation and its condition.)
- Survival of seedlings planted areas previously accessed by vehicles but where access is now prohibited. Marked by plant survival percentage.
- 2. How will the benefits gained from this project be maintained in the future?

The 2 wheel drive access, car parking and rehabilitation work will be maintained by Denmark Shire -

Infrastructure Services. The trail will be maintained by the Shire and Local Community.

Summary:

Poison Point is a recreation reserve, with the Management Order issued to the Shire of Denmark. The current, essentially unmanaged, recreational use of this reserve has environmental impacts and the Shire does need to consider appropriate management recommendations in the long-term.

It is recommended that Council provide the opportunity for a staged development approach to the provision of recreational facilities at Poison Point, thus ensuring a level of development at Poison Point that can balance the environmental and recreational desires of the community.

Background:

The Wilson Inlet Foreshore Reserves Management Plan 2008 (WIFRMP), which was adopted by Council at the Ordinary Meeting of 25 November 2008 (Resolution 11108), included a number of management recommendations, associated actions and staging timeframes specifically associated with the development of Poison Point reserve, namely:

In 2009, the Shire of Denmark was successful in obtaining grant funds of \$11,130.00 from the State Government's 2009 Environmental Community Grant Program to implement some of the WIFRMP recommendations/actions, namely develop a nature walk trail with picnic facilities and indigenous heritage interpretative signage at Poison Point, with Council's contributory funds of \$15,000.00 to be associated with the road works required to ensure appropriate vehicular access to Poison Point. Approval to Council funds being allocated to the project was considered at the Ordinary Meeting of Council held on 27 October 2009 (Resolution 121009).

The timeframe for implementation and completion of the project was originally indicated for 2009/2010 financial year. In May 2010 an extension for completion of the grant works until 30 November 2010 was approved by the Department of Environment and Conservation on account of delays in the roadworks to upgrade vehicular access to the site and to allow for further consideration of environmental concerns with the proposed works at Poison Point.

As a result of some community opposition to any works occurring at Poison Point, the Poison Point Steering Group (which was established to oversee the project and comprised Cr Bob Laing, H Heydenrych (Shire's NRM Officer), Wayne Webb (Noongar Elder representative) and D Harwood & K Koning (community members)) determined that it would be appropriate for Council to review the recommendations provided for in the WIFRMP to determine the appropriate form of development that should occur at Poison Point, noting the concerns raised by sectors of the community that the management recommendations and associated actions as provided for in the adopted WIFRMP were not the subject of community consultation.

Council considered this matter at the Ordinary Meeting of 25 January 2011 and resolved as follows (Resolution 110111):

"That with respect to Poison Point Recreational Reserve:

- Council advertise for 35 days seeking public comment with regards to Council Resolution 111108 item 9.1 of 25 November 2008 and management actions included in the Wilson Inlet Foreshore Reserves Management Plan 2008 for Poison Point Reserve (R12344).
- 2. Following the process outlined in 1. review future options for Poison Point reserve, including:

- a) the best form of protection and prevention of further degradation of this iconic site:
- b) issues of safe pedestrian and vehicular access;
- c) consideration of the environmental values and Indigenous heritage values of the site:
- d) consideration of activities which are currently being undertaken in this reserve;
- 3. Give consideration to the overall planning for access to the Wilson Inlet foreshore for the disabled and elderly.
- 4. That, with respect to the 2009 Environmental Community grant project received for development of a nature appreciation walk trail for Poison Point Reserve (R12344), Council approve the return of unspent monies (\$11,130.00 ex GST) to the Department of Environment and Conservation (DEC)."

Comment:

As per Council Resolution 110111, public consultation occurred in relation to the management recommendations and associated actions as provided for in the WIFRMP. At the close of the advertising period, a total of 42 submissions were received, comprised of:

- 8 submissions lodged supportive of the WIFRMP recommendations for the provision of disabled access to Poison Point and associated recreational facilities;
- 31 submissions lodged objecting to the WIFRMP recommendations for the provision of disabled access to Poison Point and associated recreational facilities;
- 1 multiple signatory submission/petition (containing 394 signatures) supportive of the WIFRMP recommendations for the provision of disabled access to Poison Point and associated recreational facilities; and
- 2 multiple signatory submissions/petitions (one containing 66 signatures and the other containing 43 signatures) objecting to the development of any new infrastructure at Poison Point.

Attached is the Schedule of Submissions which provides a summary of the key issues raised in the submissions and Planning & Sustainability Directorate officer comments accordingly.

As is evident from the submissions received, the community has very polarised views as to the future recreational use of Poison Point reserve, although they all reflect the following:

- the desire to retain the high natural values of the site;
- the need for "low environmental impact" to be the guiding factor in determining the level and/or form of development at the site; and
- that the primary use of the site should be for nature-based recreational experiences.

It should also be noted that within the Shire of Denmark's 2011 Community Needs and Customer Satisfaction Survey there was a question seeking comment on the concept of constructing a fully accessible (wheelchair access) path, as well as a fishing platform or structure, to enable deep water fishing at Poison Point. The survey has recently been finalised and analysed, with the results pertaining to this question as follows:

Having regard to all of the issues raised in the submissions and the original management recommendations and associated actions as provided for in the WIFRMP, it is considered that there is the opportunity to provide for a level of development at Poison Point that can balance the environmental and recreational desires of the community in the short to medium term, whilst providing the opportunity to consider further development of the site (such as the wheelchair friendly fishing

platforms and full disabled access around the Poison Point recreational reserve) subject to matters such as funding, environmental and cultural heritage impact assessments and statutory approval process being investigated/pursued further.

The short to medium term development opportunities that are considered appropriate at Poison Point on the basis that they allow Council to sensitively manage the recreational reserve include:

- providing for 2-wheel drive vehicle access to the site by resheeting the current access track surface with gravel, ensuring that all works are undertaken to minimise disturbance to the adjacent vegetation;
- development of a car parking area (maximum 4 bays with 1 bay being designated as a disabled bay), suitably located so as to ensure minimal removal of existing vegetation;
- development of an all weather nature appreciation trail, surfaced with crushed limestone, providing safe pedestrian access for the physically able and elderly (i.e. not suitable for disabled access) to deep weather fishing spots at the point; and
- development of rest-point facilities (seating, picnic tables) in suitable locations to provide for passive nature-based recreational experiences (bird-watching, picnicking, photography, painting), with facilities able to be utilised by the disabled where provided in close proximity to the parking area.

Providing the opportunity for such a staged development approach enables Council to:

- provide for some recreational use of Poison Point;
- sensitively manage Poison Point through the development stages;
- review development options for the site should it be deemed the environmental impact cannot be adequately managed; and
- review development options for the site should the issues of funding and statutory approvals not be forthcoming.

Poison or Poisson?

From reviewing the files it is evident that there has been extensive debate in the Council arena and the community for many years as to the correct spelling – Poison or Poisson. Current mapping information seems to provide reference to both spellings, with the road being referred to as Poisson and the actual point referred to as Poisson.

Officers have recently liaised with Geographic Names Committee on this matter and after researching it they have advised that Council, via a letter dated 8 August 1983 to the then Surveyor General's Department, requested the name Poisson Point Road be allocated to a portion of the road reserve that was previously named Pinniger Point Road south of Inlet Drive, and that the correct spelling of such is "Poisson". A search of Council records has confirmed that this correspondence was as a result of a Council resolution on the matter at the Ordinary Meeting of Council held on 28 July 1983.

The Denmark Historical Society Inc. advises that they consider the area is Poison Point. They do note that since the late 1950's some nearby residents referred to it as Poisson Point (which is French for fish) because they did not like the name Poison Point – which was named because of the gastrolobium plants that grow there containing a poison which killed many calves and sheep in the early years.

From an officer's perspective, both names appear to have merit and a basis for use as they have some affiliation with the area. Notwithstanding which spelling is determined as being the most appropriate, it is strongly recommended that the name of the reserve and the name of the associated road reserve need to be spelt the same. Given that for the most part the road reserve is effectively unconstructed and there is no signage associated with it as a result, it is considered appropriate that "Poison" be utilised for the spelling associated with the reserve and the road reserve.

A question was also included within the Shire of Denmark's 2011 Community Needs and Customer Satisfaction Survey in relation to the construction of a fully accessible (wheelchair access) path, as well as a fishing platform or structure, to enable deep water fishing at Poison Point.

Statutory Obligations:

There are no statutory obligations associated with the report or the officer recommendation at this stage.

Policy Implications:

There are no policy implications associated with the report or the officer recommendation at this stage.

Budget / Financial Implications:

There are no known financial implications upon the Council's current Budget or Plan for the Future at this stage as any budgetary considerations will be dependent upon grant funding being able to be obtained to undertake the majority of the actions associated with the development of Poison Point as a recreation node.

Strategic Implications:

Depending on the Council's final resolution on this matter, the WIFRMP may require to be amended accordingly.

Sustainability Implications:

Environmental:

The level of development for Poison Point will need to be considered in context having regard to the function and intended purpose of the reserve whilst ensuring a sustainable environmentally acceptable development outcome is provided, regardless of the form and extent of development proposed.

> Economic:

Depending on the form of development that is proposed for the site, Poison Point could become a tourism asset for the Shire.

Social:

The provision of access to popular facilities within the Shire of Denmark is a social obligation. The officer's recommendation provides the opportunity for improved access to the site and within the reserve to be provided in the short to medium term by vehicles and for the physically able and elderly, with the option to consider access for the disabled in the future subject to matters such as funding, statutory approvals and environmental/cultural heritage impact assessments being investigated/pursued.

Voting Requirements:

COUNCIL RESOLUTION & OFFICER RECOMMENDATION

ITEM 8.1.1 (a) MOVED: CR SAMPSON SECONDED: CR SYME Cr Syme asked whether Cr Ebbett's declaration of interest related to item 8.1.1 (a). The Shire President noted that it did not relate and that he would allow Cr Ebbett to return to the meeting to debate and vote on the motion.

4.39pm – Cr Ebbett returned to the meeting.

That with respect to the issue of "Poison" or "Poisson", Council:

- 1. Determines that "Poison" be referenced as the correct spelling;
- 2. Requests the Department of Regional Development and Lands to amend the gazetted road name of "Poisson Point Road" to "Poison Point Road";
- Requests the Department of Regional Development and Lands to amend all cartographic and topographic mapping references such that it is "Poison Point" and not "Poisson Point"; and
- 4. Advise the Department of Water, Department of Environment and Conservation, Department of Indigenous Affairs and the Denmark Historical Society Inc that the area should be referenced as "Poison Point" and not "Poisson Point".

The cost of providing universally accessible recreational facilities at Poison Point outweighs the likely benefits provided, and the environmental costs of such a development at this site cannot be justified when alternative sites exist. There are numerous alternative sites on Wilson Inlet for development as a wheelchair accessible recreational fishing site such as Poddy Shot, Denmark River Mouth, the Yacht Club, and Springdale Beach. Council money would be better spent developing these more accessible sites. 	 The level of development for the site will need to be considered in context having regard to the function and intended purpose of the reserve whilst ensuring a sustainable environmentally acceptable development outcome is provided, regardless of the form and extent of development proposed. Management of reserves is beneficial for reducing the environmental impacts resulting from human use. Poison Point Reserve requires sensitive management to maintain the wilderness experience and high environmental values currently enjoyed by visitors and locals. The adjacent unmanaged crown reserve (R22248) includes an Aboriginal Heritage Site (DIA 4580 – stone quarry) on the granite outcrop. The Aboriginal Heritage site is therefore mostly located outside of the Poison Point Reserve. DIA and Aboriginal Elders have been consulted regarding any potential issues associated with the registered heritage site. The reserve is currently accessed by a steep track which is unsuitable for 2-wheel drive access. The access track urgently requires maintenance as it is deteriorating and eroding. Shire officers consider that the proposed road works involving resheeting of the surface with gravel, reshaping for drainage and putting in two passing bays can be undertaken in an environmentally acceptable manner. It is acknowledged that improved access to the site may increase the use of the site, which may in turn impact negatively on the environmental values of the site. However, if appropriate management actions are put in place (e.g. demarcated picnic sites, parking areas and walking tracks) the impacts can be contained and managed accordingly.
