¹**Regulation 29B – Copies of certain information not to be provided ([Local Government] Act [1995] s. 5.96)**

A local government must not make available to a person copies of information referred to in section 5.94(m) or (s) unless –

- (a) the request for the information is made in the manner and form approved by the CEO of the local government; and
- (b) the CEO of the local government is satisfied, by statutory declaration or otherwise, that the information will not be used for commercial purposes.

 - D. a description of the land and its location, including lot number, primary address, and plan number
 - E. the valuation of the land to be used for rating purposes

 - I. the purpose for which a service charge is imposed, and to whom the service charge is imposed on the land

 - L. amounts received in respect of the rates or service charges on the land
 - M. any amount written off in respect of the rates or service charges on the land
 - N. the balance of the rates or service charges owing on the land
- **section 5.94 (s)** – which are particulars of the Shire of Denmark **register of owners and occupiers** under section 4.32(6) of the Local Government Act 1995 and electoral rolls, and is limited by regulation 13 of the Local Government (Elections) Regulations 1997 to the following information only:
 - O. the full name and postal address of each person making an enrolment eligibility claim
 - P. each decision to accept or reject an enrolment eligibility claim
 - Q. the date of the decision to accept or reject an enrolment eligibility claim
 - R. the expiry date of an accepted enrolment eligibility claim
 - S. details of each parcel of rateable property on the basis of which the person claimed enrolment eligibility
 - T. whether the person makes the enrolment eligibility claim as an owner or occupier or as the nominee of joint owners or joint occupiers or of a body corporate
 - U. the ward to which the enrolment eligibility claim applies
