



Road Naming within the Shire of Denmark Policy

1. PURPOSE

1. To keep a register of names that have been considered by Council to be suitable for use within the Shire of Denmark for roads that require a new name or are named for the first time.
2. To record the process that the Shire's administration must adhere to should a name be approved by Landgate's Geographic Names Committee which has not been previously considered for use by the Council.

2. POLICY

Policy

When considering a new name for potential use within the Denmark District, the Shire of Denmark will assess the name against the guidelines in Landgate's *Policies and Standards for Geographical Naming in WA*.

The names listed in the table below have been considered and approved by Council at some point in time. If known the date of former Landgate approval and/or Council approval has been noted in the comments column.

Prior to allocating any of the names in the table to rename a road reserve or name a new road reserve, the name must be referred to the Geographic Names Committee (GNC) for approval.

Should any of the names in the table be allocated to road reserves, the names will be automatically removed from the reserved names list.

Where a road or reserve name is proposed to be utilised and is not included in the table above, the Director Assets & Sustainable Development shall email all Councillors with the details of the road name request (i.e. proposed road name (including the proposed road type – i.e. street, alley, crescent etc.) the road/reserve the name is to apply to and any other relevant information advising Councillors that unless there is at least one (1) request for the matter to be referred to Council within five (5) working days of the email, then a formal request for use of the road name will be lodged with Geographic Names Committee (Landgate) for approval.

Names that refer to current or former families within the Shire of Denmark should generally only be allocated to streets or roads within the locality that the family ordinarily resides or resided.
