#### 7.1 STATE GOVERNMENTS PRESCRIBED BURN POLICIES AND PROCEDURES

The CBFCO expressed concern at learning via media of Council intentions to consult with BFAC regarding the State Government's prescribed burning response.

#### **COMMITTEE RECOMMENDATION**

**ITEM 7.1** 

With respect to the recent correspondence received from the State Government's prescribed burning policy and procedures, the Bush Fire Advisory Committee:

- 1. Welcomes the request from the Council for comment
- NOTES that the Standing Committee on Environment and Public Affairs is evaluating submissions regarding Petition No. 029 calling for an independent review of the Department of Biodiversity, Conservation and Attractions' Prescribed Burning Practices, and believe that this is an appropriate process.
- 3. BELIEVES that continued open investigation and research in relation to prescribed burning, especially on a large scale, is essential to determine the most effective bushfire mitigation strategies around towns and communities.

- 4. SUPPORTS the Council's request that the State Government provide additional resources for the early detection and rapid suppression of bushfires and in particular notes:
  - a. that a number of Department of Fire and Emergency Services funded firefighting appliances and fire sheds are well beyond their scheduled replacement dates; and
  - b. improved backup power supplies to essential communication facilities is another underfunded issue.
  - c. additional LGGS funded resources for a growing community as supported by Report 13: 2022-23 Funding of Volunteer Emergency and Fire Services, Office of the Auditor General.
- 5. NOTES that the carefully targeted reduction of fuel loadings is important for the preservation of high value community and environmental assets.

# DENMARK TOWN BFB - NO APPLIANCE

## BACKGROUND

As one of the oldest bush fire brigades in the Shire of Denmark, it is with great sadness that we do not have a bush fire appliance to represent this side of our dual-registered organisation. Our brigade did fundraising to purchase one of the first bushfire appliances in Denmark, it was purchased from Pearce Air Force Base. Then several years ago, the Shire saw fit to give us a 2.4 BFB tanker and took the yellow international appliance we had purchased ourselves. This was a reasonable deal as the old one was relatively slow but held a reasonable amount of water, so it made sense to house it at the airport (East Denmark BFB), then a few years later, it was deemed that we no longer required the 2.4 bushfire appliance (we are unsure of the reasoning behind this decision) and it was taken back and redeployed to East Denmark Bush fire brigade (where our previous appliance had been sent). We did not, in return receive our previous appliance back (that we had privately fundraised for) in this deal. I am unaware as to whatever happened exactly to our old appliance. I do believe it was possibly sold privately for profit by someone, I'm not sure if it was the Shire or the brigade that ended up with it, either way we have no appliance or compensation for our initial purchase.

## IMPLICATIONS

At the moment, we only have VFRS Urban appliances, which means that they are unavailable for use with BFB activities, including but not limited to, issuing permits, controlled burns, support of turnouts in the local area as well as deployments and bush fire preparedness & awareness safety activities. This limits the capability and availability of the brigade.

Currently, we do participate in some of these activities but moving forward have been instructed that VFRS appliances/PPE are for those activities only if it's a BFB activity, we are not to take VFRS equipment/PPE.

This also includes incidents; if we are at a bush fire and there is a VFRS callout, we currently if instructed to do so, must leave and attend the VFRS incident. As a dual registered brigade, we can

leave some crew but not an appliance, this of course is quite problematic even though we have ample crew to run another appliance or two.

The VFRS appliances are scheduled for replacement in the near future (no confirmed date at this stage) and the recommendation is not for an urban tanker but for an urban pumper and rescue capability rather than a bush fire / urban tanker.

### RECOMMENDATIONS

Our recommendation to BFAC, is that at the earliest possible occurrence, Denmark Town BFB is be provided with an appliance to enhance the fire coverage and response time from a central location (we average around 6 minutes for turning out) with highly trained (weekly training) keen and motivated volunteers with additional capability including leadership, incident management structural and hazardous situation awareness. This will help us support the other brigades, the wider community, the Shire and our homes.
