Under the powers conferred by the *Local Government Act 1995*, and under all other powers enabling it, the Council of the Shire of Denmark resolved on _____ 2026 to make the following local law.

1. Citation

This local law may be cited as the *Shire of Denmark Public Places and Local Government Property Amendment Local Law 2026*.

2. Commencement

This local law commences 14 days after the day on which it is published in the *Government Gazette*.

3. Principal Local Law

In this local law the *Shire of Denmark Public Places and Local Government Property Amendment Local Law 2026* as published in the *Government Gazette* on 6 January 2026 is referred to as the Principal Local Law.

4. Principal Local Law amended

The Principal Local Law is amended as set out in clauses 5 – 18 of this local law.

5. Clause 1.10 amended

(a) In subclause 1.10(1) delete “his or her” and insert “a person’s”.

(a) In subclause 1.10(2):

(i) delete “his or her” and insert “a person’s”; and

(ii) delete “her or she” and insert “a person”.

6. Clause 2.7 amended

In subclause 2.7(h)(ii) delete “*Firearms Act 1973*” and insert “*Firearms Act 2024*”.

7. Clause 3.1 amended

In subclause 3.1(1)(h) delete “her or his” and insert “the employee’s”.

8. Clause 3.2 amended

In subclause 3.2(1) delete “her or his” and insert “the person’s” in both instances where the term appears.

9. Clause 5.2 amended

In subclause 5.2(2) delete “Subclause (1)(a) and (d)” and insert “Subclause (1)(a) and (b)”.

10. Clause 5.6 amended

(a) In subclause 5.6(1)(b) delete “he or she” and insert “the person”.

(b) In subclause 5.6(2)

(i) after “subclause (1) insert “a”; and

(ii) delete “his or her” and insert “the authorised person’s”.

11. Clause 5.7 amended

In clause 5.7:

(a) in the definition of “aircraft” delete “*Civil Aviation Act 1988 (Commonwealth)*” and insert “*Civil Aviation Act 1988 (Cth)*”; and

(b) in the definition of “airport” delete “*Civil Aviation Act 1988 (Federal)*” and insert “*Civil Aviation Act 1988 (Cth)*”.

12. Clause 6.8 amended

Delete “she or he” and insert “that person”.

13. Clause 7.3 amended

In subclause 7.3(1) delete “her or his” and insert “their” in both instances where the term appears.

14. Clause 7.9 amended

In subclause 7.9(2) delete “her or his” and insert “their”.

15. Clause 9.5 amended

In clause 9.5 delete subclause 9.5(4).

16. Clause 11.2 amended

In subclause 11.2(2)(a) delete “section” and insert “regulation”.

17. Clause 12.4 amended

In subclause 12.4(c)(ii) delete “he or she” and insert “the authorised person”.

18. Clause 13.22 amended

Delete “her or his” and insert “their”.
