10. Tender Selection Criteria

a) Use/Activity Proposed for the Site

Soil Solutions intend on using the leased land to operate a landscaping supplies company, selling products from building sands through to manures, mulches and decorative rock. We currently operate a landscaping yard in Albany and wish to expand into the Denmark area, making it easier for us to service our existing Denmark customers.
