5. GENERAL BUSINESS

5.1 Mr Bowley – Privacy of Personal Information

Mr Bowley referred to the recent Council decision to commence the community survey and advertise a draft Privacy Policy. Mr Bowley asked when the draft policy would be advertised.

The Chief Executive Officer responded that the advertising was imminent.

5.2 Mr Bowley – Advertising of Audit Committee Meetings

Mr Bowley thanked the Council for the efforts to advertise the Audit Advisory Committee meetings and hoped that the Council had had some interested members of the public attend.

5.3 Mr Fleming – Thanks to Council and Staff & Lights Beach Working Group

Mr Fleming expressed his thanks to the Council and Shire Staff for doing a great job noting that he understood how difficult it could be at times. Mr Fleming said that he wasn't sure that people realised just how much time and effort is put in.

Mr Fleming said that he was a community member on the Lights Beach Concept Plan Working Group and felt that from the first meeting the group had made timely and significant progress.

5.4 Cr Allen – Asset Management

Cr Allen asked the Chief Executive Officer to provide an overview of the work the Shire had done around asset management.

The Chief Executive Officer said that as part of the Integrated Planning & Reporting Framework all local governments were required to have an Asset Management Plan. Mr Parker said that a significant amount of time had been applied to identify, inspect, assess and value all infrastructure assets. Mr Parker said that the process had reduced the Shire's fair value of the infrastructure portfolio significantly and the Auditor General had endorsed the Shire's approach.

5.5 Mr Bowley – Local Planning Scheme Review

Mr Bowley said that he hoped that the Shire will undertake robust consultation when the review of the Local Planning Scheme commences. Mr Bowley encouraged Council to 'think outside of the box' when it came to its methods of engagement.
