



Bushfire Emergency Evacuation Plan April 2017

Fire/Emergency Evacuation Plan

- **1. Collect any sleeping, resting children.**
- 2. Children doing craft need to pass through the kitchen area (if safe to do so) and wait further instruction in main play area.
- **3. Grab Emergency Bag.**
- 4. Take all the children through to the *outside play area*. Remain calm.

5. Ring 000.

- 6. Ring the families notifying them of the situation and request they collect their children immediately.
- 7. Try keep the children calm by reading a story from emergency bag whilst waiting for them to be collected.

Practice drills to be undertaken quarterly

*If there is a fire that has started in the Kitchen and the children can't pass through from the craft room, then the door leading directly outside into the carpark will need to be used (exit 2). Access to this door (exit 2) will pass by exit 4 enabling emergency access from the remainder of the building.

**If the Caregiver is in the room, then all persons should exit via exit 2 and shelter in the outdoor play area. If there are any remaining children in the house, the Caregiver should re-enter via exit 1, grab the emergency bag, collect any remaining children, and leave back via the sliding door (exit 1) into the outdoor play area.

***If the fire spreads whilst collecting the resting children, the Caregiver should leave via the rest/sleep room (exit 3). This leads directly outside into the carpark where there is pedestrian access to the back of the property and outdoor play area.

****People not property is the priority, so only the emergency bag will be removed from the house. All other property will remain inside the home.

Bushfire Management Plan

- Follow steps 1-6 on the Little Jumbucks Fire/Emergency Evacuation Plan
- Children whose parents have not made it to the Family Day Care Centre to collect them before immediate emergency evacuation is required will need to be placed into the Caregiver's vehicle (which fits all four pre-school aged children) and exit the locality
- As an alternative, the Caregiver can walk all children to one of the nominated collection points on the Area Emergency Evacuation Plan
- Update parents on
- Keep calm, keep the children calm and wait until the parents arrive.

Bushfire Preparation Check list (all year round)


- Students, parents, caregivers and work experience staff have all been made aware of the Family Day Care's Bushfire plan.
- Caregiver has established contact with local emergency services including DFES, the local volunteer fire brigade, Denmark Police, and incorporated their feedback into the plans (as required)
- Little Jumbucks Family Day Care has incorporated key bushfire safety messages in their curriculum.
- Evacuation plans are practiced at least once every term and extra awareness is raised during the bushfire season running from October to April.
- Student records and parent contact details are regularly maintained. The emergency kit is regularly checked for its contents and all equipment tested to ensure it is operational.

- Multiple safer locations have been identified (refer Area Emergency Evacuation Plan)
- An Asset Protection Zone (20 metre radius) around the building is regularly cleared of all rubbish, long dry grass, bark and flammable materials in accordance with the Shire of Denmark's Annual Fire Regulations Notice.

Selected route to be nominated on the day based on the location/direction of the bushfire threat.


Route A) Right into Paterson street, right into Kingdon street, cross the road, enter McLean Oval via the pedestrian accessway and shelter on the oval. Wait for children to be collected.

Route B) If access to Paterson street is not safe, then exit via Pomery Lane, turn left and follow to the end, turn right onto Kingdon Street, cross the road, enter McLean Oval via the pedestrian access and shelter on the oval. Wait for children to be collected.

Route C) Turn right onto Paterson Street, left onto Thornton Street, cross the road and enter into the Denmark Primary School Oval. Children can be collected at the Oval carpark.

<u>Route D</u> Turn left onto Pomery Lane, right onto Kingdon Street, and left onto Brazier Street. Collection point on corner of Brazier and Barnett Streets.
