### 2. REPORTS & PRESENTATIONS

### 2.1 Wilson Inlet Catchment Committee (WICC)

The Wilson Inlet Catchment Committee is a non profit, community run corporation committed to promoting land use practices that protect our environments, natural and cultural heritage, biodiversity and agricultural resource base through;

- Education
- the promotion and facilitation of sustainable landuse
- capacity building; and
- recognising and rewarding best practice.

Shaun Ossinger and Ian Marshall attended the meeting and provided an overview of the Wilson Inlet Catchment Committee. Mr Ossinger provided information on the funding currently available to the group and the various programs that are being delivered.

### 2.2 Plane Tree Precinct Project

The Chief Executive Officer provided an update on the Plane Tree Precinct Project. The project comprises 3 components;

- RSL Hall
- Public Realm
- Cottage Crafts building

The RSL Hall is complete and was delivered on budget. H+H Architects in Albany have been appointed to complete the detailed design work for the public realm. Local Builder Westruct (Steven Madaffari) has been engaged to complete the new administration addition to the Cottage Craft and Heritage School Building.

The estimated cost of the project has increased with Council to consider these additional costs at the 2019 Interim Budget Review.

### 2.3 Councillors Access to Employees

With a change in structure, the Councillors requested further information on access to employees. Previously access was only provided to the CEO and Directors.

Given the reduction in Directors and in an effort to expedite the flow of information to the community, the CEO advised that access to staff at a management level was now appropriate. In stating this, various policies and procedures would require updating.

### 2.4 Christmas Collage

Staff prepared a short movie to celebrate the Shire's 2018 achievements. This was presented to the Elected Group and will be published on social media.

### 2.5 Director Assets and Sustainable Development

The Chief Executive Officer provided an overview on the recruitment process and the likely timeframes.

### 2.6 Local Government Act Review

The Executive Assistant & Governance Coordinator provided an overview on the Local Government Act review. The Shire of Denmark staff will run a workshop for Councillors in February 2019.
