3. ELECTION OF SHIRE PRESIDENT & DEPUTY SHIRE PRESIDENT

3.1 ELECTION OF SHIRE PRESIDENT

The Chief Executive Officer called for nominations for the position of Shire President.

Cr Lewis nominated Cr Gibson, who accepted the nomination in writing.

There being no further nominations, the Chief Executive Officer declared Cr Gibson elected unopposed.

Cr Gibson assumed the chair as the Presiding Person.

3.2 ELECTION OF DEPUTY SHIRE PRESIDENT

The Chief Executive Officer called for nominations for the position of Deputy Shire President.

Cr Youel nominated Cr Devenport, who accepted the nomination in writing.

Cr Phillips nominated Cr Lewis, who accepted the nomination in writing.

The Chief Executive Officer conducted a ballot, the result being Cr Lewis five votes, and Cr Devenport four votes.

The Chief Executive Officer declared Cr Lewis as elected as the Deputy Shire President.
