5. REPORTS

5.1 SOBER SUPER HERO CAMPAIGN UPDATE

Sergeant Matt Hartfield advised that the *Sober Super Hero Campaign* was completed and that there had been positive feedback from the community on the programme. Sgt Hartfield said that the Denmark Police would be interested in supporting next years' campaign.

Sgt Hartfield noted that during the campaign many of the same people had been pulled over for roadside testing and suggested that perhaps a change to future campaigns could be considered to wider the participation.

Cr Seeney thanked Sergeant Hartfield for all the hard work undertaken by his staff.

5.2 COURTESY SPEED SIGNS UPDATE

The Director of Assets and Sustainable Development advised that the signs had been applied for and had been due to arrive 22 March 2021 however, they had not been received by the Shire until 1 April 2021. Mr King said that because of the delay in receiving the signs and Depot Staff being on leave, it had meant they had not been erected in time for the Easter break.

Mr King advised that officers would be providing feedback to WALGA regarding the length of time to receive the Speed Signs.

Cr Roger Seeney enquired about requesting the signs in advance in light of the freight delays or the possibility of the Shire acquiring their own signs.

OUTCOME

6. GENERAL BUSINESS

6.1 LETTER FROM THE NORNALUP RESIDENTS AND RATEPAYERS ASSOCIATION

Cr Roger Seeney presented the Committee with a letter received from the Nornalup Residents and Ratepayers Association and suggested that independent agencies be approached by the Nornalup Residents and Ratepayers Association (eg. Main Roads WA) to request letters of support for their requested works. Cr Seeney also suggested that the Committee ask Council to write letter of support as Cr Seeney can see the safety issues and feels they need addressing immediately.

6.2 FATALITY STATUS

Mr Lenton advised that in 2020 there had been 11 fatalities in the Great Southern and to date, in 2021, there had been 12.

6.3 DENMARK PRIMARY SCHOOL PARKING

Ms Lockyer discussed progress with plans for parking around the Primary School to improve safety and capacity. Ms Lockyer said that she believed that the Department of Education had written to the Shire requesting costing/draft concept plans for Thornton Road and Brazier Street.

OUTCOME

- *The Director of Assets and Sustainable Development will search for the request from the Department of Education and notify the Committee of any progress at the next meeting.*

The Committee implied their support plans for parking upgrade due to the safety and the ongoing issues raised with lack of parking.

Discussion ensued and Zone signs around the school were also discussed. Mr King has noted that there appears to be lack of signage at the Barnett Street/Brazier Street intersection and will action a request with Main Roads.

6.4 DENMARK HIGH SCHOOL EXIT ROAD WIDENING

Mrs Kendell queried widening of the exit from the School for busses, due to the impact of busses crossing over lanes when existing onto South Coast Highway.

Mr King suggested organising an independent road safety review to assess options available which could then be referred to Main Roads WA.

NORNALUP RESIDENTS AND RATEPAYERS ASSOCIATION INC

PEDESTRIAN AND CYCLE ACCESS – NORNALUP WALPOLE

The Nornalup Residents and Ratepayer's Association (NRRRA) wishes to raise with the Shires of Denmark and Manjimup, Main Roads WA, and WA Police and other authorities, the dangerous lack of pedestrian access across the Frankland River at Nornalup.

Access across Frankland River at Nornalup is currently via a narrow two lane bridge, with no pedestrian walkway. The bridge is necessarily used by a variety of vehicles, including heavy freight trucks, TransWA buses and local and tourist traffic including caravans. With increasing tourist interest in the area, a growing number of residents on the west side of the bridge, and no alternative river crossing within a reasonable distance, the bridge is increasingly being used by pedestrians, and with the 70km speed limit across the bridge it, is only of time before a serious injury or fatality occurs.

The NRRRA has been in discussion with the Department of Biodiversity, Conservation and Attractions (DBCA) about the proposal to establish an upgraded walk trail between the Walpole and the Valley of the Giants, as part of Covid related stimulus expenditure. At present, aside from the bridge at Nornalup, the only option for the trail to cross the Frankland River is via Sappers Bridge, well upstream from Nornalup, and which would require a lengthy deviation. Additionally, this route would bypass Nornalup and deprive the town of tourism opportunities and make it impractical for Nornalup residents and visitors to access the trail. Furthermore, the objective of DBCA to make the proposed trail suitable for all abilities would be hampered by a river crossing at Sappers Bridge.

NRRRA believes that – subject to detailed engineering design and MRWA endorsement – a cantilevered, separated, road level walkway on the north side of the Frankland Bridge and Nornalup would remedy the current situation. This will both assist in making the river crossing safer and contribute to the tourism potential of Nornalup.

We therefore request that you urgently consider this matter. We would be happy to meet with all parties to discuss the matter and expedite a resolution.
