- No fixture shall be installed without a valid permit issued by the Shire.
- This permit is valid for 12 months unless otherwise stated.
- Permit renewal fees must be paid annually by the due date. Renewal notices will be sent to permit holders 6 weeks prior to renewal.
- All fixtures must comply with accessibility standards and not impede pedestrian movement.
- All fixtures must be readily moveable at applicants' expense upon request by the Shire.
- Non secured items must be removed at end of business hours daily.
- The Shire of Denmark reserves the right to revoke or alter the terms of the permit.
- This permit must be kept at the permit holder's premises and be available upon request.
- Any non-approved fixtures may be removed by the Shire of Denmark at the landowner's cost.
- Processing time may be up to 4 weeks from date of submission.

FOOTPATH FIXTURE SPECIFICATIONS

To Maintain public safety, accessibility and amenity, all fixtures must adhere to the following minimum specifications.

1 - Pedestrian Clearance

• A minimum clearance of 2000mm must be always maintained on the footpath for safe pedestrian movement.

2 - Fixture Placement:

- Fixtures must not obstruct sight lines at intersections or crossings.
- No items are to be placed within 500 mm from back of kerb or tactile paving.
- Items must be located wholly within the applicant's property frontage unless otherwise approved.
- Fixture must not exceed a maximum height of 1000mm.
- Fixture must not exceed a maximum weight of 50kg.

3 - Design & Material:

- Fixtures must be of high-quality commercial-grade materials.
- Items must be safe, weather-resistant, and secure.
- No sharp edges, protrusions or removable items are permitted on the fixture.
- Fixture must not negatively impact on the streetscape and appearance of the area.
- Must not damage Shire footpath or any Shire assets.

4 - Accessibility:

- Fixtures must not impede access for people with disabilities.
- Clearance of 1000mm must be maintained from pram ramps, handrails, and footpath gradients.

5 - Maintenance:

- Fixtures must be maintained in clean, good condition by the permit holder.
- The permit holder is responsible for any damage to public infrastructure resulting from the installation.
